## NOTICE INVITING TENDER

The undersigned, on behalf of "North Eastern Electric Power Corporation Ltd." (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work:

**Name of the work: "Engagement of 13 (Thirteen) Nos. of labourers in different categories for providing assistance in routine works under various Wings of PLHPS, NEEPCO, Arunachal Pradesh on job contract basis for the period w.e.f. 01.05.2026 to 31.03.2027 (335 days)."**

### TERMS & CONDITIONS:

- 1. Scope of work:** - The work shall be carried out as per the specifications mentioned in the BOQ enclosed as **Annexure -I**. The work is to be executed and completed as per direction of the Head of HR Department / Manager (HR), PLHPS, NEEPCO.
- 2. Rate per unit basis:**
  - 3.1.** Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
  - 3.2.** Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over-writing, changes and cuttings shall be initialed by the bidder.
  - 3.3. Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and any other charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
- 3. Estimated Amount: ₹ 64,46,402.00** (Rupees Sixty Four Lakh Forty Six Thousand Four Hundred Two) only inclusive of all applicable taxes, cess etc..
- 4. Payment Terms:**
  - 4.1** Payment will be released after satisfactory completion of the work for the respective period as certified by the concerned Head of the Department under which the labourer/s is/are engaged / Head of HR / Manager (HR), PLHPS, NEEPCO as per clauses 52,53, 54 and 55 of the Condition of Contract, Part-I of Vol-I. No part payment/advance payment shall be entertained.

- 4.2 In case of any defect in the work detected after the completion of the work shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
5. **Paying Authority:** The paying authority shall be the **Head of Finance / Sr. Manager (F)**, PLHPS, Yazali (A.P).
6. **Detailing-In-Charge:** Head of HR Department / Manager (HR), PLHPS, NEEPCO, 43 KM, Yazali, A.P.
7. **Time of completion:** - **335 (Three Hundred Thirty-Five) days with effect from 01.05.2026 to 31.03.2027**
8. **Labour act and other relevant regulations:** Strict adherence to all statutory labour rules, regulations, e.g. inter alia, Employees' Provident Funds and Miscellaneous Provisions Act 1952, Employees' Compensation Act 1923, and amendments thereon including relevant notifications issued time to time by the Govt. of India and State Government shall be ensured by the contractor. The contractor must be a registered establishment under the EPF &M.P. act 1952 and shall specify Independent Code No. All essential personal safety requirements as per relevant safety engineering and safety codes shall be strictly adhered to and the contractor himself shall ensure safety measures and availability of proper safety gears, personal protective equipment – PPE, Uniform etc. and he will be fully responsible for the materials engaged by him at site. The contractor shall be fully responsible for providing insurance coverage to the extent of Rs 5 Lac to each and every labourer engaged by him, as per requirement at PLHPS, NEEPCO. The Contractor shall also fully responsible for timely payment of wages to the labourers engaged.
9. **Compensation for Delay:**  
In case of delay in work of items as per stipulations indicated above, compensation for delay at the rate of 0.5% (zero-point five percent) of the contract price per week or part thereof of delay shall be deducted subject to a maximum of 10% (Ten percent) of the contract sum.
10. **Defect Liability:** Any defect in the work, detected during or after completion of the work during the contract period i.e. within 01.05.2026 to 31.03.2027, shall be made good by the Contractor at his own risk and cost and for this no extra payment shall be made by the Corporation. The nature and extent of defects, if any, and the liability period for the Contractor for making good the same shall be assessed and decided by the Detailing-In-Charge. The decision of the Detailing-In-Charge, in this regard shall be final and binding.
11. **Security Deposit:** Not required
12. **Earnest Money Deposit:**  
Earnest Money of ₹ 1,28,928.00 (One Lakh Twenty Eight Thousand Nine Hundred Twenty Eight) only and ₹ 64,464.00 (Rupees Sixty Four Thousand Four Hundred Sixty Four) only for SC/ST Contractor shall be deposited through SBI Collect. Non-submission of EMD shall result in cancellation of the bid document. However, firms/ contractors registered in NEEPCO and UDYAM Registration are exempted from depositing earnest money along with tender in their respective class of registration.


**15. Terms & Condition for Submission of Tender:**


