The undersigned, on behalf of "North Eastern Electric Power Corporation" (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably PLHPS registered contractors for execution of the following work:

Name of the work: "Supply and engagement of 2(two) nos. of labourers comprising of 01(one) Skilled and 01(one) Semi-skilled, for providing assistance to routine works of various Wings of PLHPS, NEEPCO, 43 KM, Yazali, Arunachal Pradesh on Job-Contract basis for the period w.e.f. 01.09.2025 to 31.03.2026 (212 days)"

TERMS & CONDITIONS:

1. **Scope of work:** - The work viz. " Supply and engagement of 2(two) nos. of labourers comprising of 01(one) Skilled and 01(one) Semi-skilled, for providing assistance to routine works of various Wings of PLHPS, NEEPCO, 43 KM, Yazali, Arunachal Pradesh on Job-Contract basis for the period w.e.f. 01.09.2025 to 31.03.2026 (212 days) " is to be carried out as per the specifications mentioned in the BOQ enclosed as **Annexure -I**. The work is to be executed and completed as per direction of the **Engineer -in- charge (EIC) i.e. General Manager (Tech), S&T Division, 43 KM, A.P.**
2. **Rate per unit basis:**
 - 3.1. Rate against each item shall be "FIRM" till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over-writing, changes and cuttings shall be initialed by the bidder.
 - 3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and any other charges etc. No extra charge on this account shall be paid by the corporation. Forest Royalty clearance Certificate is to be submitted by the Contractor along with their bills for the forest products, if any, utilized by them for the work.
3. **Estimated Amount: Rs 5,69,882.00** (Rupees Five Lac Sixty-Nine Thousand Eight Hundred Eighty Eight Only) inclusive of all applicable taxes, cess etc..

- 4.1 Payment will be released after satisfactory completion of work for the respective period as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.
- 4.2 In case of any defect in the work detected after the completion of the work shall be made good by the contractor at his own risk and cost, and no extra payment shall be made by the corporation.
5. **Paying Authority:** The paying authority shall be the **Head of Finance / Sr. Manager (F), PLHPS, Yazali (A.P).**
6. **Engineer-In-Charge:** The Engineer-In-Charge shall be **General Manager (Tech), S&T Division, 43 KM, A.P.**
7. **Time of completion: w.e.f. 01.09.2025 to 31.03.2026 (212 days)**
8. **Labour act and other relevant regulations:** Strict adherence to all statutory labour rules, regulations, and amendments by the Govt. of India and State Govt. and should be complied by the contractor. The contractor himself will be responsible for compliance of the provision of the said act, as per Govt. notification. The contractor must be a registered establishment under the EPF & M.P. act 1952 and scheme thereunder and shall specify Independent Code No. All necessary/adequate personal safety measures/ requirements as per relevant safety engineering and safety codes shall be kept available at site. The contractor himself shall ensure proper use of the safety measures. The contractor shall be fully responsible for making arrangement against insurance of Labourers and materials to be engaged at site.
9. **Compensation for Delay:**
In case of delay in work of items within the stipulated period indicated in **clause no.8** above, compensation for delay at the rate of 0.5% (zero-point five percent) of the contract price per week or part thereof of delay shall be deducted subject to a maximum of 10% (Ten percent) of the contract sum.
10. **Defect Liability:** Any defect in the work, detected during or after completion of the work during the contract period i.e. within w.e.f. 01.09.2025 to 31.03.2026, shall be made good by the Contractor at his own risk and cost and for this no extra payment shall be made by the Corporation. The nature and extent of defects, if any, and the liability period for the Contractor for making good the same shall be assessed and decided by the Engineer-in-Charge. The decision of the Engineer-in-Charge, in this regard shall be final and binding.
11. **Security Deposit:** Not required
12. **Earnest Money Deposit:**
Earnest Money of **Rs 11398** (Rupees Eleven Thousand Three Hundred and Ninety-Eight) only and **Rs 5699.00** (Rupees Five Thousand Six Hundred Ninety-Nine) only for SC/ST Contractor shall be deposited through SBI Collect. Non-submission of EMD shall result in cancellation of the bid document. However, firms/ contractors registered in NEEPCO and UDYAM Registration are exempted from depositing earnest money along with tender in their respective class of registration.
