The undersigned, on behalf of the Corporation hereby invites online bids under Single stage Two Envelope system through Domestic Competitive Bidding (DCB) route with a validity of 180 (One Hundred Eighty Days) from MSME registered firms who are Manufacturer of Rubberized products for “Supply of Rubberized Items for Dikrong Power House, Ranganadi H.E. Plant, NEEPCO, Arunachal Pradesh”, as detailed herein under::

1. SCOPE:

2. The scope of work shall be “Supply of Rubberized Items for Dikrong Power House, Ranganadi H.E. Plant, NEEPCO, Arunachal Pradesh” as per BOQ and delivery of same to Power House Store, Hoz, Papumpare Dist, Arunachal Pradesh. The terms and conditions governing this tender are detailed in the subsequent sections of the Bid Document. The detailed BOQ are given as **Annexure – A** respectively.

3. COMPLETION TIME:

The delivery period of materials shall be 30 (thirty) Days from the date of issue of detail Supply order.

4. QUALIFYING REQUIREMENT:

- a) **TECHNICAL:** The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.
- (i) MSME Certificate showing to be manufacturer of rubber products.
 - (ii) Documents showing the brand of the materials manufacture by the firm.
 - (iii) The bidder shall have executed/supplied Rubberized materials to any Govt. /PSUs organizations in the order as specified below:
 - (a) A single order of not less than ₹. 1.60 lacs executed by the firm in the last 03(three) years and the bidder shall submit the copy of the said supply order.
or
 - (b) Two orders of not less than ₹. 1.20 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders or.
 - (c) Three orders of not less than ₹. 0.80 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders.
 - (iv) Copy of provisional/ migrated GST ID, PAN number, Bank account No (along with IFSC code) number should be submitted along with the Bid. The documents submitted in support of the credential should be valid till the opening of the Bid as specified in the Tender.

b) FINANCIAL:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Solvency certificate, not older than 6 months, by the firm from a nationalized / scheduled bank specifying the firm is financially sound to execute the contract amounting to ₹. 3.0 Lacs.
- (ii) Annual turnover by the firm in the best three financial years out of last five financial year ending March 2019 should not be less than ₹. 2.0 Lacs.
- c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted online along with the Techno-Commercial bid under Envelope – I. **Bids submitted without fulfilling the qualifying requirement of MSME shall be rejected.**
- d) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.
- e) Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to supply the item, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- f) Each bidder shall submit only 1 (one) bid. A bidder who submits or participates in more than 1 (one) bid will be disqualified.
- g) If an agent submits bid on behalf of one manufacturer/ dealer, the same agent shall not submit a bid on behalf of another manufacturer/dealer in the same tender

5. E-TENDERING / E-PROCUREMENT :

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded, filled in bids are to be submitted/ uploaded through e-tendering system of NEEPCO Ltd. at <https://etenders.gov.in> .

6. PARTICIPATING IN THE BID:

Portal Registration:

The bidders intending to participate in the e-tendering and download the detailed bid document have to register themselves in the portal <https://etenders.gov.in> . Relevant information about the bidder required during the registration is available in the portal.

Vendor registration : Vendor Registration in the portal is free of charges. The details of registration procedure is available on the web site <https://etenders.gov.in/e procure/app> under category “Downloads” . The details is also given under Section-II ' Instruction to Bidders' as Annexure-B ('Instruction for online Bid Submission').

7. PROCEDURE FOR PAYMENT OF BID FEES & EMD:

- 7.1 **Bid Fees:** Since only MSME registered firms are eligible for participating in the NIT, Bid fees is exempted.
- 7.2 **EMD:** Since only MSME registered firms are eligible for participating in the NIT, EMD is exempted.
- 7.3 Exemptions for MSME's shall be applicable under the Govt. of India norms under PPC guidelines.
- 7.4 Also the Price preference as applicable to MSME's as per Govt. of India Norms, during evaluation of the Bid shall be applicable.

9. Submission of bids shall not automatically construe qualification for evaluation. The owner reserves the right to reject any or all bids, or to annul the bidding process and reject all the bids and reject all the bids for any justified and genuine grounds, without thereby incurring any liability to the affected bidders, nor does it have any obligation to inform the bidders of the ground for such action on the part of the owner.
