Sealed tenders under Single Stage Two Envelope system with 180 (one hundred eighty) days validity are invited from reputed Manufacturers or Authorised dealers for Supply, Transportation, Erection, Testing and Commissioning of one number Silent Type 500 KVA, 415V, 3 Phase, 50Hz Diesel Generating Set with Standard Control & Protection Panel and AMF Panel and other associated works at Tuirial Power Station, NEEPCO, Kolasib, Mizoram.

Cost of Tender paper: Rs.1120.00 (Rupees One thousand one hundred twenty) only in the form of DD/ BC drawn in favour of "NEEPCO Ltd", payable at **SBI, Tuirial Branch, Mizoram (Br. Code: 18311)**.

Earnest Money : Rs. 80,000.00 for General & **Rs. 40,000.00** for ST category subject to submission of necessary ST Certificate from the Competent Authority. Earnest Money shall be furnished in the form of **Call Deposit / Term Deposit/ BG** in favour of NEEPCO Ltd, TrHEP from any Nationalised / Scheduled Bank.

QUALIFYING REQUIREMENT

- The bidder shall be a Manufacturer or an Authorised Dealer of DG Set.
- Bidder shall have average annual financial turnover of at least Rs 20,00,000.00 (Indian Rupees twenty lakhs only during the preceding 3 (three) years from the date of submission of Techno-Commercial bid.
- Individual bidder shall have supplied, erected, tested and commissioned at least 1(one) no of DG set of 250 KVA or above capacity to North Eastern Electric Power Corporation/ any other PSU/ Government Dept., which is in satisfactory operation for a period of at least 3 (three) consecutive years within a period of 7(seven) years prior from the date of submission of Techno-Commercial bids.
- Shall have Service Center in NE Region.

The interested bidders are requested to submit the duly filled up of the download document (hard copy) along with **earnest money & cost of tender document**.

Latest Banker's Certificate indicating amount in support of solvency for evaluating the financial capability, Latest Income Tax Clearance Certificate / Exemption Certificate (for ST)/ copy of PAN Card, Copy of GST Registration, copy of Registration under EPF from appropriate Authorities, documents in support of qualifying requirements, etc are to be submitted along with the Detailed Tender Document.
