**Earnest Money/ Bid Security:** Earnest money amounting to ₹ 5,60,300/- (Rupees Five Lakhs Sixty Thousand Three Hundred) only to be deposited through online transfer to the account of the Corporation. The said earnest money will be 50% in case of ST supplier subject to submission of necessary ST Certificate from the Competent Authority.

MSME registered firms are exempted from submission earnest money subject to submission of MSME Certificate.

### **REGISTRATION FOR PARTICIPATION IN BIDS:**

Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "**Online bidder Enrolment**" on the CPP Portal which is free of charge.

As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra, etc.), with their profile.

Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC/e-Token.

All the bidders are requested to get themselves registered well in advance and no extra time will be considered for submission of bids for the delay in on-line Bidder Registration, if any.
