GENERAL INSTRUCTIONS:

1.0 QUALIFYING REQUIREMENTS OF BIDDERS:

1.1 TECHNICAL QUALIFYING REQUIREMENT:

a) The bidders (Individual/company/Firm) should have successfully completed one of the following during the period of 7(seven) years ending on the in which this NIB is floated.

i). One completed similar nature work costing not less than the amount equal to 80% of the tendered value.

OR

ii) Two completed similar nature of works each costing not less than the amount equal to 50% of the tendered value.

OR

iii) Three completed similar nature of works each costing not less than the amount equal to 40% of the tendered value.

The bidder must have submitted along with Techno-commercial bid i.e. the copy of past experience of works (as mentioned above) executed with completion certificate in any State Govt./Central Govt./PSU. Otherwise, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as disqualified bid.

The bidders shall furnish copies of the following valid Registration Certificates with Techno-commercial Bid:

- vi) Registration Certificate for GST.
- vii) PAN (Permanent Account Number) for Income Tax.
- viii) Valid Electrical contractor License.
- ix) Valid Electrical supervisor license.
- x) Valid PF registration Certificate.

11. BID FEE (Off line): Bidders shall have to deposit Bid Fee (Non-refundable) for participation in this instant tender of Rs 224.00 (Rupees two hundred and Twenty Four) only including GST (as per Government applicable norms). The cost of tender document shall deposited through "SB COLLECT" in to NEEPCO AGBP SBI Account (Nonrefundable) drawn in favour of "NEEPCO Ltd., Bokuloni, Dibrugarh, Assam. In case of MSME firm there will be no bid fee and for that the bidder has to submit MSME certificate along with the application for bid document.

12. EARNEST MONEY DEPOSIT (EMD) Off- line: Bidders shall have to deposit Earnest Money as mentioned above in the NIB. The earnest money shall be deposited through "SB COLLECT" in to NEEPCO (AGBP) SBI Account drawn in favour of "NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam. . In case of MSME firm there will be no EMD and for that the bidders have to submit MSME certificate along with the bid document.

5	Select "PSU" against type of Corporation and go to NORTH EASTERN ELECTRIC POWER CORPORATION LTD" then submit.
6	Select "AGBP parties" and submit.
7	Feed necessary information in the appropriate boxes.
8	Payment through "internet Banking" SBI Branch, SBI Buddy or Card payment etc.
9	Print copies of receipt and submit.

14. IMPORTANT INFORMATION AND DATE:

Bid Fee	INR 224.00(Rupees Two Hundred & Twenty four) only (non-refundable). In case of MSME no bid fee.
Earnest Money Deposit (EMD)	INR 3,566.00 (Rupees Three Thousand Five Hundred & Sixty Six) only. In case of MSME firm EMD is not required.
Bid Validity	90 (Ninety) days.
