Earnest Money/ Bid Security: Earnest money amounting to **₹ 40,000/-** (Rupees forty thousand) only to be deposited through online transfer to the account of the Corporation. The said earnest money will be 50% in case of ST bidders subject to submission of necessary ST Certificate from the Competent Authority.

MSME registered firms are exempted from submission earnest money subject to submission of MSME Certificate.

Only one bid against one group from a party offering individually as well as under proprietorship/ partnership firm shall be accepted.

Latest Income Tax Clearance Certificate / Exemption Certificate/ Copy of PAN Card, GST registration, Postal address, email are to be submitted along with the bid.

Bidders participating as Micro/Small Enterprise (MSE) shall submit a copy of the certificate issued by competent authority (District Industries Centre, Khadi & Village Industries Commission/ Board, Coir Board, NSCI, Director of Handicrafts & Handloom or any other body specified by Ministry of Micro, Small & Medium Enterprise).
