## 2. BIDDING PROCEDURE:

The Bidder shall submit Bids under Single -Stage Two-Envelope bidding system through online as follows:

Price Bid (ENVELOPE -2):

Shall contain Price Bid. Price Bids of only those Bidders who Qualify in Techno-Commercial evaluation shall be opened.

3. TIME OF COMPLETION: The time allowed for completion of the work in all respect shall be 60 (Sixty) days from the date of issue of work order.

## 4. BID FEE:

Bidders shall have to pay Bid Fee (non-refundable) of INR 590.00 (Rupees Five hundred & ninety only) including GST for participation in this instant NIB. Applicable bank charges shall be borne by the bidder. The bidder shall make the payment to NEEPCO through SB Collect in to Neepco, State Bank of India Account drawn in favour of "NEEPCO Ltd., AGBP, Bokuloni Chariali Branch, Dist. Dibrugarh, Assam. # 7. QUALIFYING REQUIREMENT:

# 7.1 Technical Qualifying Requirement:

The Bidder shall have experience of successful completion of the similar works(s), fulfilling any one of the following during the last 7(Seven) years, ending on the last day of the month previous to the one in which the tender is invited.

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Two similar completed works costing not less than the amount equal to 50% of the estimated

iii) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

The bidders shall compulsorily submit along with the Bid, the following authenticated documentary evidence in support of technical qualifying requirement.

- Copies of Work Orders placed on them by Clients/ Owners issued from Government. / PSUs.
- Certificates of Clients / Owner issued from Government / PSUs indicating successful Completion of Orders placed on and completed by them, indicating the date of completion of the work(s) and value of completed work.

# 7.2 General Qualifying Requirement:

The bidders shall furnish the copies of the following valid Registration Certificates with Techno-commercial Bid:

- (i) Registration Certificate for GST.
- (ii) PAN (Permanent Account Number) for Income Tax.
- (iii) Valid Solvency Certificate from any Nationalized Bank.
- (iv) Valid Trade License.

Authenticated documentary evidence in support of qualifying requirements, as mentioned under Clause 1 above, shall be submitted in Techno-Commercial Bids. Bids submitted without fulfilling the qualifying requirements shall be outright rejected.

## Participation in Bids:

# 8.1 E-Tendering / E-Procurement:

This tender is being processed through e-tendering / e-procurement system. The bidding documents are to be downloaded from <a href="https://etenders.gov.in">https://etenders.gov.in</a> and bids are to be submitted / uploaded through above e-tendering system. Guidelines for e-tendering system are available on e-tender portal.

# 8.2 Registration for Participation in Bids:

- a) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a>) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- b) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for the accounts.
- c) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- d) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.) with their profile.
- e) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- f) Bidders can then log in to the site through the secured log-in by entering their user ID/password and the password of the DSC/e-Token.

Bidders are requested to get themselves enrolled on the e-Procurement Portal (URL: <a href="https://etenders.gov.in/eprocure/app">https://etenders.gov.in/eprocure/app</a>) well in advance and no extra time will be considered for submission of bids for the delay in enrolling on the e-Procurement Portal.

# 9. SUBMISSION AND OPENING OF BIDS:

9.1 Bidders shall prepare and submit their bids online in <a href="https://etenders.gov.in">https://etenders.gov.in</a> as per timeline mentioned in Clause 11 below. Online bidding forms will be available in the above website. Submission of online bids is mandatory for consideration of the bids by NEEPCO.

Besides online submission, bidders shall also compulsorily submit the following documents (offline mode) as provided in Detailed Bid Document.

- a) Payment receipt of Bid Fee and Earnest Money Deposit (EMD) deposited through SB-COLLECT in to Neepco, State Bank of India Account drawn in favour of "NEEPCO Ltd., AGBP, Bokuloni Chariali Branch, Dist. Dibrugarh, Assam (in Original).
- b) Copies of work order of past experience of similar nature of work issued from Government / PSUs alongwith copies of completion certificate indicating the date of completion of the work.
- c) Valid Solvency Certificate from any Nationalized Bank.
- d) Valid Trade License
- e) Power of Attorney (as per format provided at Section-V of Bid documents (in original).
