Envelope No -1(*Techno-Commercial Bid*): Shall contain Earnest Money Deposit (EMD), E-receipt of vendor registration fee *and bid fee*, *all* documents in support of qualifying requirements *of Techno-Commercial Bid*.

Envelope No-2 (*Price Bid*): Shall contain Price Bid in the format at Annexure ó I & II

## 2.2 E-Tendering / E-Procurement

## 3. PARTICIPATION IN BIDS

#### (a) Portal Registration for e-tendering:

The Bidders who have already registered in NEEPCO® e-tendering portal having valid registration need not to register again. However, such bidders are to ensure that their registration in the e-tendering system is valid till the completion of the entire bidding process of the relevant NIB.

## Portal registration fee:

The fees for Bidder Registration in the portal is Rs. 3000.00 (Rupees three thousand) only per year (Non refundable).

The procedures for registration in the e-tendering portal are as under.

- **Step-1:** Visit the e-tendering portal https://neepco.abcprocure.com
- **Step-2:** Click on new Register and submit the online Form for company /bidder details required. Already registered bidder having a valid registration may directly log-in to the etendering portal.
- **Step-3**: The bidder has to map the digital certificate (Class-II or Class óIII Signing & Encryption Certificate) with his login-id as per the name of the registered company for approval process. **Step-4:** Payment for bidder registration in the e-tendering portal:

Bidders shall make the payment of non-refundable Bidder registration fee of Rs.3000.00 (Rupees Three thousand only) through õSB-COLLECTÖ of State Bank of India as per procedures/steps elaborated in Cl. No. 3 (b) below.

Step-5: After payment of bidder registration fee through õSB-COLLECTÖ of State Bank of India, this system generated receipt shall be downloaded and send it to the Contracts & Procurement Department, NEEPCO, Shillong at e-mail ID: contract\_neepco@yahoo.com to advice the service provider for approval of the Biddersø registration.

- (b) Procedure / Steps for payment by SB-COLLECT of State Bank of India (for payment of portal registration fee):
- **STEP-1:** The bidder shall visit url/web page <a href="https://www.onlinesbi.com/prelogin/institutiontypedisplay.htm">https://www.onlinesbi.com/prelogin/institutiontypedisplay.htm</a> on any internet browser.
- **STEP- 2:** State Bank Collect page will appear.

- **STEP -3:** In the new screen, select PSU Name as õNorth Eastern Electric Power Corporation Limitedö and Submit.
- STEP-4: In the new screen, select Payment Category as õSHILLONG- PARTIESÖ.
- **STEP-5:** New Screen will appear, here the bidder has to fill all the required information for the payment as under:
  - i) Under Name of Payer: The Bidder is to filled up his Name and Address.
  - ii) Under Short Details of Payment: The Bidder shall indicate Portal Registration Fees,
  - iii) Under Type of PAYER: The Bidder is to select VENDOR OR CONSULTANT whichever is applicable.
  - iv) Under CIN in case the Payer is a company: The bidder is to fill up his CIN in case of may a company, otherwise kept blank.

  The Bidder may select option as per convenient and make the payment.
- **STEP-8:** After successful payment, the system will generate receipt.

Bids submitted without fulfilling the qualifying requirements shall be outright rejected. Price Bids of those Bidders shall only be opened, who fulfils the minimum qualifying requirements as indicated under Serial No. 4 above and have submitted the requisite EMD in the manner prescribed in the Bid Documents. The date of opening of Price Bids will be intimated later on to the bidders who will be selected in techno commercial Bid. Price Bids of un-successful Bidders, who fail to demonstrate the minimum qualifying requirements, shall not be opened and the EMD in that case shall be returned immediately after opening of Price Bids.

- b. Bidders shall submit following documents in offline mode in addition to online mode as described in the GENERAL INSTRUCTIONS at C in SECTION-II: INSTRUCTION TO THE BIDDER:

The offline documents shall reach this Office within the scheduled date and time mentioned below.

The documents received by the Corporation in offline mode as specified above after the stipulated date and time will be returned unopened to the Bidder and his online Bid will not be considered for evaluation. NEEPCO will not be responsible for any delay of wrong delivery or non-delivery of the above documents.

6. REVERSE AUCTION:

- i) The bidders whose price bids have been opened may require to participate in the Reverse Auction event conducted as per Business Rules and Conditions for Reverse Auction which is incorporated in the bid document is attached at Section-III of this Part. The Purchaser reserves the right to go for Reverse Auction process to finalize the tender or may finalize the tender without Reverse Auction, if required. However, the decision to conduct Reverse Auction or not will be conveyed to the techno-commercially qualified bidders after opening of Price Bid. In case the Purchaser decides not to go for the reverse auction procedure for the tender, the price bids already opened and evaluated shall be considered for finalizing the award.
- ii) Bidders shall furnish the Declaration (Form-H, Section-IV of Tender Forms & Schedule of Rates) along with the techno-commercial bid in their letter head.
- iii) Bidders not confirming to participate in Reverse Auction if conducted by the Purchaser, then their original quoted price shall be considered as final.
- iv) The bids of the techno-commercially qualified bidders who have confirmed acceptance to the Purchaser on reverse auction, but do not participate in Reverse Auction, then their original quoted price shall be considered as final.
- v) If a bidder does not want to quote any price below the opening/starting/ base price during Reverse Auction, their õLogged Inö during Reverse Auction itself shall be considered as Participation. Then their original quoted price shall be considered as final.
- vi) The following procedure shall be adopted for the Reverse Auction.
  - a) It shall be Purchaserøs discretion to use the Lowest Evaluated Cost already evaluated amongst the Price Bids or any other price as the opening /starting/ base Price in Reverse Auction.
    - If the L1 Price is taken as opening /starting/ base price for conducting the Reverse Auction, then for the purpose of convenience, the L1 price shall be corrected to nearest lower multiple of 100.
  - b) The minimum Price quoted by a bidder while concluding the Reverse Auction shall be considered as the lowest bid. The bidder shall be called the lowest bidder / Auction winner and the price quoted by the Auction Winner shall be called lowest price.
  - c) After completion of reverse auction, the purchaser will compare the lowest price offered by the Auction Winner in reverse auction along with the original price bid of the same bidder already opened to assess the percentage decrease in price.
    - The percentage decrease of the Lowest price with respect to the price quoted by the same bidder in Price Bid shall be effected on each rates of items in the BOQ of the Auction Winner. Accordingly, a decrease of such percentage shall be effected on the overall price quoted by the Auction Winner in the Price Bid.
- vii) After completion of reverse auction, the lowest bidder has to fax/e-mail the duly signed filled in prescribed format (**Annexure-C**: Price Confirmation) under this Part confirming the price quoted within 24 hours of auction without fail.
- viii)If no bid is received during reverse auction within the specified time duration of the online reverse auction, the price quoted by the Techno Commercially qualified bidders shall be processed to evaluate the lowest bid.
- ix) If the L1 bidder as per the original Price Bid does not participate in the e-reverse auction and the Auction Winner price received during reverse auction happens to be the same as the L1 price evaluated on the basis of price Bids of the Techno Commercially qualified
