

The North Eastern Electric Power Corporation Ltd. (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Govt. of India invites sealed bids in prescribed format with minimum 180 (one hundred eighty) days validity from the contractors/suppliers of Meghalaya under the single stage, single envelop bidding system for "Construction of 3(three) nos. of Bus Shed at Mawphu Village, EKH District, Meghalaya under CSR & S Scheme" as per the scope of works mentioned below:-

Other terms and conditions.

- 1. The Earnest Money Deposit of Rs. 13,000.00 (Rupees thirteen thousand) shall be submitted along with the tender in the form of Demand Draft/Banker's Cheque/Bank Guarantee drawn in favour of "NEEPCO Ltd." From any Nationalized/Scheduled Bank.
- 2. Non-transferable tender documents can be purchased from the office of the CGM (C)/ HoP, Wah Umiam Stage-III HEP, Mawsynram, Meghalaya, Pin- 793113 on any working day between 10.00 AM. to 3:00 PM with effect from 28/03/2022 against payment of Rs. 1000/- (Rupees one thousand) only plus 18 % GST (Rs. 1000 + Rs. 180 = Rs. 1180) as applicable in the form of non-refundable Demand Draft/ Banker's cheque in favour 'NEEPCO Ltd.' payable at Shillong, issued from any Nationalized Bank/Scheduled Bank.
- 3. The overall scope of work covered under this contract for Construction of 3(three) nos. of Bus Shed at Mawphu Village, EKH District, Meghalaya under CSR & S Scheme.
- 4. The commencement of work and time of completion shall start from the date of issue of Letter of Intent or Work Order.

5. The contractors/suppliers must have registration under any State/Central Government Department or any recognized Organization.

- Copy of Income Tax/PAN Card and Professional Tax certificate clearance of current validity are to be submitted along with the application.
- The intending bidders are requested to visit the work site to assess the requirement of the work, availability of the water, labours, accommodation to the work site etc. before submission of their tenders.
- 8. Bidders shall quote their rates in the supplied Bill of Quantities/Schedule of Rates enclosed with the tender papers.
- Rates quoted by the bidders shall be inclusive of all applicable taxes and duties including GST. Rates have to be quoted in figures and words.
- 10. In case of delay in completing the work, ½% (half percent) of the total value of the work shall be recovered from the bill per week of delay subject to a maximum of 10% (ten percent) of the total value of the work.
- 11. The bidder shall submit the EPF Registration Number otherwise EPF deduction in respect of both the employees and employer's contribution will be made from their bills as per existing relevant norms. However this will not relieve the contractor from his responsibility.
- 12. Laws, Regulations and Acts pertaining to engagement of labours, Environment protection, Safety etc. shall be applicable.
- 13. Security deposit: Full amount of earnest money deposit by the contractor along with the tender shall be accepted as Initial Security Deposit (ISD). Security Deposit being 10% (ten present) of the total value of work executed less proportionate ISD shall be retained from the contractor's bills for due performance of the work and the same shall be released on expiry of the Defect Liability Period (DLP) of 12 (twelve) months from the date of completion.
- 14. Payment terms: First & Final bill shall be released to the contractor on successful completion of the work in all respects. No escalation shall be payable against this work and no claim in this regard shall be entertained. No advance is payable under this contract.
- 15. The contractor shall have to supply all materials and labours etc. required for successful completion of the work in all respects.
- The contractor shall adopt suitable quality assurance programme to the satisfaction of the Engineerin-Charge.
- 17. In case the work has not been carried out as per the specification or to the satisfaction of NEEPCO or the contractor causes damage to the property of NEEPCO/Dorbar authority or any other damages not mentioned herein, NEEPCO shall have the right to recover any amount as suitable from the bill/Security Deposit/CPG/any other amount due to the contractor.
- 18. Each bidder shall submit 1 (one) either individually or as a partner in a Joint Venture.
- 19. Withdrawal of bids at any stage is not allowed. If due to unavoidable circumstances, the bidder wishes to withdraw his/her bid by written request, the same will be allowed only by forfeiting the CPG/EMD. The bidder shall be disqualified for re-submission of bid.
- 20. The Engineer-in-Charge, may at his discretion, approve and authorize the contractor to sub-let, transfer or assign the whole or any part of the work. Nevertheless, any such approval or authorization shall not relieve the contractor from his responsibility.
- 21. From commencement to completion of the work as a whole, the contractor shall take full responsibility for the care thereof and for taking precaution to prevent loss or damage.

24. In the event, the date of opening of bids is declared as a closed holiday of NEEPCO, the bids shall be submitted by the bidders as per the stipulated time. However, date of opening of bids will be on the next working day at the appointed times.

25. The Micro & Small Enterprises (MSEs) shall have to provide valid Exemption Certificate, if any, against payment of Bid Fee and Earnest Money Deposit (EMD)/CPG.

26. The Corporation reserves the right to extend the last date and time for submission of bids.

27. The Corporation reserves the right to reject any or all tenders or to annul the bidding process without assigning any reason thereof.
