The undersigned on behalf of “North Eastern Electric Power Corporation” (NEEPCO) hereby invites sealed tender with a validity of 180 (One Hundred Eighty Days) from experienced/reputed/preferably RHEP registered contractors for execution of the following work. Terms & conditions are detailed herein under:

1. **Name of the work:** Cleaning of floating Logs, Bamboo, Debris of Banana trees etc from reservoir , 41 Km, RHEP, Yazali, A.P.
2. **Scope of the Work:-** The work to be executed as per Technical Specification attached in the tender document and as mentioned in the schedule of item enclosed in the tender document. Moreover, instruction of Site-Engineer is final and binding.
3. **Rate per unit basis:**
 - 3.1. Rate against each item shall be “FIRM” till completion of work irrespective of any quantity variation. No escalation of the rates will be admissible.
 - 3.2. Bidders are to quote unit rates in figures and words for the items indicated in **Annexure-I** of tender document. The tendered amount shall be legibly written in English in ink, in Indian currency both in figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent issue of work order. In case of discrepancy between unit rate and the total amount, the unit rate will prevail and the amount will be corrected accordingly during evaluation. If the bidder does not accept the corrections made as above, his bid will be rejected and the EMD submitted will be forfeited. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
 - 3.3. **Taxes, Duties & Levies:** Bidders shall quote their rates against respective item specification inclusive of all taxes including GST, Building Cess and all charges etc. No extra charge on this account shall be paid by the corporation.

Estimated Amount:

- 4.1 ₹. 4,90,697.00 (Rupees four lacs ninety thousand six hundred ninety seven) only.
- 4.2 Building Cess, GST and other taxes & charges as applicable will be deducted from work value.

4. Payment Terms:

- 5.1 Payment will be released after satisfactory completion of work as certified by the Engineer-In-Charge. No part payment/advance payment will be entertained.
- 5.2 100% Payment will be released on successful completion of the work and no extra payment shall be made by the corporation.

5. **Paying Authority:** The paying authority shall be Deputy General Manager (F), RHEP, Yazali (A.P).

6. **Time of Completion:** The work shall be completed within 20 (twenty) days from the date of issue of the Order.

7. **Compensation for Delay:**

In case of delay in work of items within the stipulated period indicated in **clause no.7** above, compensation for delay at the rate of 0.5% (zero point five percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10% (Ten percent) of the contract price.

8. Security Deposit:

The nature of the work is such that there shall be no security deposit

9. Earnest Money Deposit :

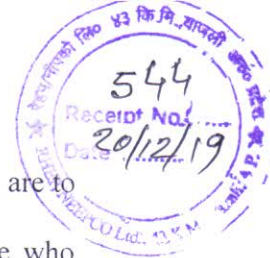
Earnest Money ₹. **12,267.00** (Rupees twelve thousand two hundred sixty seven) only for General Contractors/Firm & ₹. **4907.00** (Rupees four thousand nine hundred seven) only for SC/ST contractor shall be submitted in the form of Bankers cheque /Demand Draft duly pledged in favour of NEEPCO Ltd., Yazali, Lower Subansiri, Arunachal Pradesh. Our banker is S.B.I., Yazali – 9917. RHEP. Non submission of EMD, wherever applicable, shall result in cancellation of the bid document. However firms/contractors registered in NEEPCO are exempted from submitting of earnest money along with tender in their respective class of registration.

 - ii) Complete address of the Bank with branch details.
 - iii) Type of Bank account (Saving/current/Cash credit).
 - iv) Bank account number (indicating core Banking account number), if any.
 - v) IFS Code (11 digit)/MICR code as applicable.
- i) E-mail address of the vendor/authorized official along with mobile n number (for receiving the update status of payment) if any.
