North Eastern Electric Power Corporation Limited (NEEPCO) invites single stage two envelope bids with 180 (one hundred eighty) days validity through online bidding system (e-tender) from reputed experienced Consultant/ Engineers/ Laboratory having recognition from CPCB/ SPCB/ PCC/ MOEF & CC, New Delhi for the following work at Tuirial Hydro Power Station, Mizoram.

**Qualifying requirements:** The bidder should have experience in testing of water /air as mentioned in scope / BOQ and have laboratory recognized by National Accreditation Board for Testing and Calibration Laboratories (NABL).

Cost of Bid/Tender: NIL.

Earnest Money/ Bid Security: Earnest money amounting to ₹ 15,000/- (Rupees Fifteen Thousand) only to be deposited through online transfer to the account of the Corporation. The said earnest money will be 50% in case of ST supplier subject to submission of necessary ST Certificate from the Competent Authority.

MSME registered firms are exempted from submission earnest money subject to submission of MSME Certificate.

This tender is being processed through e-tendering/ e-procurement system. The bidding documents are to be downloaded from https://etenders.gov.in and bids are to be submitted / uploaded through above e-tendering system. Guidelines for e-tendering system are available on e-tender portal.

#### **REGISTRATION FOR PARTICIPATION IN BIDS:**

Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app) by clicking on the link "**Online bidder Enrolment**" on the CPP Portal which is free of charge.

As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra, etc.), with their profile.

Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC/e-Token.

All the bidders are requested to get themselves registered well in advance and no extra time will be considered for submission of bids for the delay in on-line Bidder Registration, if any.

#### SUBMISSION AND OPENING OF BIDS:

Bidders shall prepare and submit their bids online in https://etenders.gov.in. Online bidding forms will be available in the above website. Detailed Bid document can be downloaded from this website after vendor registration. In the online Bid submission, Bidders will submit their Bids using their digital signature.

Submission of online bid is mandatory.
