North Eastern Electric Power Corporation Limited, a leading Miniratna Category-I Public Sector Enterprise under the Ministry of Power, Government of India, invites bids from selected prospective bidders under Single-Stage Single Envelope bids through Domestic Competitive Bidding (DCB) route for carrying out the work of "Renovation of Executive Director's Chamber and Conference Room of office of the Executive Director (Arunachal), Doimukh, Arunachal Pradesh" at an estimated cost of INR 2,42,372.00 (Rupees Two Lac Forty-Two Thousand Three Hundred and Seventy-Two) only including GST.

1. **BIDDING PROCEDURE:** The Bidder shall submit Bids under Single-Stage Single-Envelope bidding system. Single envelope shall contain Bid Security Declaration (BSD), documents in support of Qualifying Requirements, Techno-Commercial Bid and Price Bid.
2. **TIME OF COMPLETION:** The time allowed for completion of the work in all respect shall be 15 (Fifteen) days from the date of issue of Detailed Work Order (DWO).
3. **EARNEST MONEY DEPOSIT:** No Earnest Money shall be submitted. However, bidder has to submit a Bid Security Declaration in the format enclosed as Part-IV of Bid Document.
4. **SCOPE OF WORK:** Renovation of Executive Director's Chamber and Conference Room of office of the Executive Director (Arunachal) with fixing of PVC and WPV Louvers wall paneling along with PVC ceiling paneling with aluminum cladding.
5. **QUALIFYING REQUIREMENTS:** Bidder should meet the following eligibility criteria as on the date of his bid submission and should continue to meet these till the award of the contract.

Bidder must

- a) be a natural person, private entity, public entity (State-owned enterprise or institution),
- b) Be a provider of the Non-consultancy Services offered with valid registration regarding GSTIN, PAN, EPF, as applicable to the subject Services.
- c) not be insolvent, in receivership, bankrupt or being wound up, not have its affairs administered by a court or a judicial officer, not have its business activities suspended and must not be the subject of legal proceedings for any of aforesaid reasons.
- d) Not stand declared ineligible/ blacklisted/ banned/ debarred by the Procuring Organisation or its Ministry/ Department from participation in its Tender Processes;

6. Submission and Opening of Bids:

- The Bid shall be packed in a single envelope and shall be submitted in Single stage.
- Envelope shall contain Bid Security Declaration Form, documents in support of qualifying requirement duly signed and Price Bid.
- Envelope shall be sealed and super-scribed as "Renovation of Executive Director's Chamber and Conference Room of office of the Executive Director (Arunachal), Doimukh, Arunachal Pradesh".
- The Bidder shall seal the envelopes and address it to the officer who has invited the Tender under reference.

7. BID VALIDITY: 90 (Ninety) days from the date of opening of Bids.

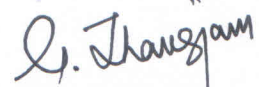
8. TENDER TIMELINE:
