The North Eastern Electric Power Corporation (NEEPCO), a public Sector Enterprise under the Ministry of Power, Government of India invites Sealed quotations for 180 (One hundred eighty) days validity for "Supply of Water Supply materials for day to day Maintenance works of AGBP, NEEPCO Ltd." as per terms and conditions as stated below.

4. Bidders shall have to submit self-attested documents as mentioned above in On-line.
5. **SUBMISSION OF BID:** The bid shall be submitted in online only.
6. EARNEST MONEY DEPOSIT (EMD) OFF-LINE: Quotation submitted without earnest money shall be liable for rejection.
 - (a) For general :- 2.50 % on quoted value.
 - (b) For ST/SC :- 1.50 % on quoted value.

Bidders shall have to submit Earnest Money as mentioned above in a Sealed **Envelope** superscripted as "**Earnest Money for NIQ No. AGBP/CWC/07 Dated.03.10.2016.**" on or before bid submission date & time as mentioned below. The EMD shall be in the form of Demand draft from a Nationalized Bank drawn in favour of NEEPCO Ltd, Bokuloni Chariali, Dibrugarh payable at State Bank of India, Bokuloni Chariali Branch, Dibrugarh. **Bid without EMD in the manner specified above shall be summarily rejected.**

7. Subject to the other conditions being fulfilled, preference shall be given to SSI/NSIC units as per Govt. policy and guidelines.
8. Failing to comply above or without submission of any one of the above mentioned documents or criteria, the bid shall not be considered for **any evaluation and summarily rejected**

The registration shall be valid for one year from the date of registration. The Bidders who have already registered in NEEPCO's e-tendering portal having valid registration need not to register again. However, such bidders are to ensure that their registration in the e-tendering system is valid till the completion of the entire bidding process of the relevant NIB. Relevant information about the bidder required for registration is available in the portal.

ii. Bidder Registration Fee:

The fee for Bidder Registration in the portal is Rs.3, 000.00 (Rupees Three thousand) only per year (Non-refundable). Vendor's fee for registration in on line either by net banking or NEFT/RTGS. Except these no other forms of registration is allowed.
