Sealed tender with minimum 90 ( Ninety ) days validity are invited from reputed Firms/Contractors/suppliers for "Supply and delivery of the Coarse Sand for filter media of Permanent water Treatment Plant of Kopili Hydro Electric Plant , NEEPCO Ltd. ,Umrongso, Dima Hasao District , Assam" as per the description of items , Unit and quantity required for R&B Division.

#### **Terms and Conditions:**

- 1. The bid should be submitted in Sealed Envelope super scribed with "Supply and delivery of the Coarse Sand for filter media of Permanent water Treatment Plant of Kopili Hydro Electric Plant, NEEPCO Ltd., Umrongso, Dima Hasao District, Assam", NIT No. 73/2017-18/KHEP/C & P (C)/Dt. 27.05.2017".
- 2. Bidder should have **valid work permit** and **PAN** to supply the materials.
- 3. It is the bidder's sole responsibility that all the necessary formalities related to supply the required materials to the respective site from all concern divisions, departments by maintaining all statutory norms. Any kind of misinformation, false documents submission etc. by the bidder will lead to disqualification and departmental legal action to the bidder.
- 4. **"Coarse Sand"** indicates to the good quality sand of particle size between 2.00mm to 4.75mm i.e. should be pass through IS Sieve No. 4.75mm. It should be hard, durable, chemically inert, clean & free from organic matter & other harmful impurities i.e. alkaline, clayey material, salt, mica, decayed vegetable etc. It should have the finest modulus from 2.5 to 3.5 & silt contain should not be more than 4%.

- 5. **Price Basis:** The Price shall be quoted on **F.O.R. Umrongso** and its respective sites basis indicating all charges towards freight and insurance and Taxes & Duties. All prices and rates shall be clearly indicated both in figures and in words.
- 6. <u>Taxes & Duties</u>: Taxes and duties will be paid at actual prevailing at the time of dispatch against submission of documentary evidence.
- 7. <u>Tender Fee</u>: Tender Fee of Rs 1,000.00 (nonrefundable) in the form of Demand draft/banker cheque drawn in favour of NEEPCO Ltd., payable at the STATE BANK OF INDIA, KHEPA Branch, Garampani (Branch Code 4812), Umrongso, Dima Hasao, Assam have to be submitted along with the offer.
- 8. <u>Earnest Money Deposit</u>: Rs. 8000/- for General and Rs. 4000/- for SC/ST/KHEP affected people/supplier only to be submitted along with the tender in the form of Bank Guarantee / DD issued by Nationalised Bank in favour of NEEPCO Ltd., payable at the STATE BANK OF INDIA, KHEPA Branch, Garampani (Branch Code 4812), Umrongso, Dima Hasao, Assam. Tenders without EMD shall be summarily rejected.
  - i) EMD submitted by successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released only after delivery of the entire quantity of the items to the satisfaction of the Corporation.
  - ii) Suppliers/Firms/ contractors which registered as SSI or MSME and hence exempted from submission of EMD / PBG etc. should mention the same enclosing valid/ current authentic documentary evidence in support of such registration to avail the said exemptions.
  - iii) EMD of all unsuccessful bidders will be returned only after finalization of the bid.
  - iv) If the bidder withdraws the bid while it is under consideration, his EMD shall be forfeited along with other action as per norms of the Corporation.
- 9. <u>Delivery Period:</u> The materials shall be delivered at site within **4(four) weeks** from the date of issue of Supply Order.
- 10. <u>Liquidated damage:</u> LD @ 0.5% (Half percent) on the contract value for per week of delay in delivery subject to a maximum of 10% on the contract value shall be applicable.
- 11. **Payment:** 100% payment inclusive of all taxes and duties shall be made on receipt of materials at site in full & good condition in actual measurement certified by the EIC and against submission of bill.

#### 12. PAYMENT OF FINAL BILL: -

Final measurement shall be made on completion of the work only when the EIC has issued a certificate of completion. Payment will be made to the contractor on the basis of final measurement adjusting all outstanding recoveries and the amount due from the contractor on account of this contract. The Contractor/Agent has to produce Forest Royalty Clearance Certificate (FRCC) to the Engineer-In-Charge before final payment against their Contract Bills if any forest produce used in the work.

#### 13. Submission of Bid:

13.1 The duly signed bid should be submitted in sealed envelope super scribed with "Supply and delivery of the Coarse Sand for filter media of Permanent water Treatment Plant of Kopili Hydro Electric Plant, NEEPCO Ltd., Umrongso, Dima Hasao District, Assam", NIT No. 73/2017-18/KHEP/C & P (C)/Dt. 27.05.2017" at the office of the undersigned by means of registered post or in person only under the bidder's letter head with details like complete address, telephone/ fax no., dealing person etc. so as to reach at this end on or before the due date. Offer received through fax / mail / etc. shall not be acceptable.

- 13.2 A signed copy of the tender specification must be submitted along with the bid in acceptance of NIT conditions. The tender may be downloaded from Corporation's website <a href="https://www.neepco.co.in">www.neepco.co.in</a>.
- 14. The bids will be opened at the time and date mentioned below in presence of authorized representative (if any) of the bidders in the **Office Chamber of Deputy Manager(C),C&P,KHEP,NEEPCO**. No electronic recording device will be permitted during opening of the bids.
  - i) Last Date and Time of receipt of bids : 15:00 hrs of 21.06.2017.
  - ii) Date and Time of opening of bids : 15:30 hrs of 21.06.2017.
- 15. In the event of holiday/ bandh etc. on the stipulated bid opening date, the bids received shall be opened in the very next working day.
- 16. Bids received later than the prescribe time limit shall be disposed-off as per Corporation's norms for late receipt of bids.

#### 17. Legal requirements:

- 17.1 The contractor will be responsible for compliance of all statutory provisions relating to minimum wages, Provident Fund etc. in respect of the labour engaged during the contract.
- 17.2 The contractor shall comply with the requirements of the EPF & MP Act 1952. If registration under the Act is not complied, both employees' and employer's contribution shall be deducted from the bills as per actual engagement of labour.
- 17.3 The contractor shall also be liable for depositing all taxes, levies etc. on account of service rendered by it to concerned tax collection authorities from time to time as per extant rules and regulations on the matter.
- 17.4 The contractor shall maintain all statutory registers under the applicable law.
- 17.5 It is the sole responsibility of the contractor to maintain all the legal requirements to supply of the materials to the site in good condition. NEEPCO will not take any responsibility in the part of contractor on any legal complications during this supply work. All statutory norms should be followed by the contractor.
- 18. All texts and amounts of the bid shall be legibly written. The language and currency applicable are English and Indian currency respectively. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between unit rate and total amount, the total amount evolved by multiplying unit rate and quantity shall be considered. In case of discrepancy between lump sum amount and breakup, the lump sum amount shall prevail. In such case the bidder shall adjust the breakup as and when requested for billing purpose.
- 19. The quantity of the materials to be supplied as mentioned in the NIT is indicative and is liable to change during the time of placing the order.
- 20. Any action on the part of the bidder to revise the price or to change the structure of the price at his own instance after opening of the bid and within the validity of the offer shall not be acceptable.
- 21. The Corporation does not bind itself to accept the lowest tender and reserves the right to waive any formality in regard to submission of tender or to reject any or all tenders without assigning any reason thereof in the interest of the Corporation.
