The North Eastern Electric Power Corporation (NEEPCO), a Mini Ratna Category-I, Public Sector Enterprise under the Ministry of Power, Government of India invites bids under Single-stage in 2 (two) Envelope Bids with 180 (One hundred eighty) days validity through Domestic Competitive Bidding route for the following work under TGBPP, NEEPCO, Monarchak in prescribed Schedule form of tender as detailed hereunder:

1. (i) Name of the Work : Construction of Guest House at TGBPP, NEEPCO, Monarchak, Sonamura, Tripura.
(ii) Estimated Cost : **Rs. 80, 73,423.00** (Rupees Eighty Lakh Seventy Three Thousand Four Hundred and Twenty Three) only.
2. Earnest Money : **Rs: 1,61,500/-** (Rupees One Lakh Sixty One Thousand Five Hundred) only in the form of Demand Draft / Banker's Cheque of any nationalized Bank drawn in favour of **NEEPCO Ltd.**, payable at Sonamura. EMD of unsuccessful bidders will be returned after award of the work.
Tender submitted without EMD shall be rejected outright.
3. Time of Completion : **12 (Twelve) months** from the date of placement of Letter of Intent.
4. Tender Document Fee : **Rs.1000/-** (Rupees One Thousand) only in the form of Demand Draft/ Banker's Cheque drawn in favour of **NEEPCO Ltd.**, payable at Sonamura.
5. Date of Commencement of Sale of Tender Document. : Documents can be downloaded online w.e.f. **08.12.2016** (10:00Hrs.) to **27.12.2016** (17:00Hrs.) from the website <https://neepco.abcpurchase.com> after registration by the vendor.
6. Last Date & Time for Submission of Bid. : Upto 17.00 hrs of **29.12.2016**.
7. Date and Time of opening of Techno-Commercial Bids : At 10.30 Hrs. of **30.12.2016**.
The date of opening of Price bid will be intimated to the technically qualified bidders in due course of time.
8. **Qualifying Requirements:** The intending bidder shall produce the following documentary evidence to satisfy the minimum qualifying criteria as specified below, the fulfillment of which is a pre-requisite for evaluation of the Techno-Commercial Bid. As the civil work is inclusive of electrical work, the bidder must have the registration of electrical contract of minimum class III of Tripura PWD, Electrical Work or equivalent, or bidder should have the joint venture with electrical contractor of class minimum class III of Tripura PWD, Electrical Work or equivalent, or bidder may sublet the electrical work to electrical contractor of minimum class III of Tripura PWD, Electrical Work or equivalent class. Civil contractor will be fully responsible for both civil and electrical work. The prescribed time limit is inclusive of time period for electrical work. The bidder registered as Micro, Small & Medium Enterprise are exempted from paying applicable bid fee and earnest money deposit subject to submission of valid and relevant document/ certificate.
- 8.1 **General Qualification & Experience:**
 - 8.1.1 Copy of Income Tax PAN, VAT registration, Labour Registration (Central), Service Tax Registration and Professional Tax Clearance Certificate of current validity are to be submitted along with the application.
 - 8.1.2 The bidder must be registered with the Provident Fund Organization. Bidder should submit a copy of the EPF registration along with the tender application, otherwise 24.85% (comprising of 12% labour wage+12% employers contribution+0.85% administrative charge) on the labour wage will be deducted

from the bill of successful bidder and the same will be deposited in NEEPCO, EPF trust.

8.1.3 Experience of having successfully completed similar nature of civil work inclusive of electrical work during last 7 years should be either of the following:-

i) Three similar works costing not less than the amount equal to 40% of the estimated cost of civil and electrical works separately.

or

ii) Two similar works costing not less than the amount equal to 50% of the estimated cost of civil and electrical works separately.

or

iii) One similar work costing not less than the amount equal to 80% of the estimated cost of civil and electrical works separately.

Note: Similar works meant in (i), (ii) & (iii) above are related to Building works viz. Plain & Reinforced cement concrete, Brick & Structural works, Water supply & Sanitary fittings, etc. and internal electric installation of building.

8.2 Financial:

8.2.1 Minimum Average Annual Turnover:

Minimum Average Annual Turnover in the best 3 (three) financial years out of the last 5 (five) financial years, ending 31st March of the previous financial years, should not be less than **Rs 121 lac** (Rupees One Hundred twenty one) lac.

8.2.2 The liquid Asset:

The bidder should have liquid asset or/and evidence to availability of unutilized credit facilities of not less than **Rs 17 Lac (Rupees seventeen Lac)**. The Certificate of Banker regarding the availability of unutilized credit facilities (Fund based or Non-Fund based) shall not be dated earlier than 30 (thirty) days prior to the latest date for submission of bids.

Liquid Asset = Current Asset – (Inventory + Pre-Paid expenses)

8.2.3 Net Worth:

Net worth of the bidder as on last day of the preceding financial year, ending 31st March of the previous financial year should not be less than 50% of the paid up capital. The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit and Loss Account less (a) Expenses not written off (b) Loss in Profit & Loss Account if not reduced from Reserves.

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 3(three) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/ Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

8.2.4 Bid Capacity:

The available Bid Capacity of the Bidder at the time of submission of Bid calculated as under should not be less than the estimated cost of the work put to tender:

Available Bid Capacity = $A \times N \times 2 - B$ Where,

A = Maximum value of works executed in any one year during last 7(Seven) years (at current price level).

N = Completion time of the proposed work in years i.e. Eight months = 0.67 year.

B = Value at current price level of existing commitments and on-going works (as on the latest date for bid submission) to be completed in next Eight months = 0.67 year.

Bid capacity shall be assessed at the time of submission of Techno-commercial Bid, for which the bidder shall have to submit documentary evidence in support of "A" & "B" above along with their Bid.

9. In case date of opening of Bids is declared as holiday in NEEPCO, TGBPP Office, date of opening will be following working day at the same appointed time.
10. **Every page of the Tender documents shall be signed and sealed by the bidder and submitted as a token of acceptance of the terms and conditions stipulated.**
11. **Compensation of delay:** Liquidated damage / Penalty for delay will be @ 0.5 % of the value of the balance work per week subject to maximum 10% of the value of work.
12. **Bidding Procedure:**

The Bidder shall submit Bid Documents Online under the Single-Stage Two-Envelope bidding system as follows:-

Envelope No. 1: This shall contain scanned copy of Tender Document Fee, Earnest Money Deposit (EMD) details, scanned copy of documents in support of Qualifying Requirements and Techno-commercial Bid.

Further, the Bidder has to submit original Demand Draft / Banker's Cheque in respect to Tender Document Fee and Earnest Money Deposit physically / by post to the Office of the undersigned within last date and time of the tender submission. Delay in receipt of the same will be considered as disqualification for participation in the tender. NEEPCO will not be responsible for any postal delay.

Envelope No. 2: Shall contain Price Bid. Price Bids of only those Bidders who qualify in the Techno-Commercial bid evaluation shall be opened.
