- 8) **Price:-** Rate shall be quoted both in figure and words in Annexure-I at FOR Basis at Guwahati.
- 9) **Tax:-** The C-Form against 2% CST shall be issued by the Paying Authority.
- 10) **Delivery:-** The material shall be at ready stock in Guwahati and shall be delivered immediately on receipt of Order..
- 11) **Quantity Variation:-** Quantity variation up to $\pm 5\%$ is acceptable.
- 12) **Payment:-** Payment shall be made within 30 (Thirty) days of delivery of material in full and good condition at site. Payment shall be made through RTGS for which Bank details should be submitted by the Bidders with their Bills.
- 13) **Penalty for delay in delivery:-** The delivery period for supply will be the essence of the orders issued from time to time. In the event, the successful bidder fails to supply within the stipulated delivery period as indicated in the Supply Order without valid and convincing reasons, penalty will be levied to the extent of **0.5 % (zero point five percent)** per week subject to maximum of **10 % (ten percent)** of the order value of the goods in respect of which the default in delivery takes place. The Corporation reserves the right to adjust liquidated damages either against the Performance Security Deposit or any amount that may be due or becomes due to the Supplier in any form.
- 14) **Force Majeure:-** Within the stipulated period, if delay has occurred due to “Force Majeure” conditions, which are beyond the control of the Supplier, payment of penalty as per Clause No. 14 by the Supplier to NEEPCO Ltd., on account of delay in delivery may be waived at the discretion of the Executive Director (MM). The Supplier shall, however, apply to the Executive Director (MM) for waiver of payment of Penalty/Liquidated damages in such cases, supported by documentary evidence of such occurrence. Decision of the Corporation as regards to acceptance of the reasons stated by the Supplier vis-à-vis imposition of penalty is final and binding on the Supplier.

The Corporation shall not commit itself to accept the lowest offer and also reserves the right to reject any or all the Bids received without assigning any reason thereof.
