Sealed single part quotation with minimum one year validity are invited from the manufacturer/ dealer for finalization of rates contract for the period of 1 year to supply and delivery of Welding Electrodes as and when required to Kopili Hydro Electric Plant, NEEPCO Ltd., Umrongso, Dist. Dima Hasao, Assam. The specification and tentative quantity of the Electrodes are mentioned in the enclosed Annexure.

Terms and conditions:

1. **Price basis:** The prices shall be quoted FOR Umrongso basis, the charges towards taxes & duties, freight & insurance charges and any other charges shall be indicated separately.
2. The rates to be quoted by the bidder only for the items as specified in the enclosed annexure.
3. **Payment terms:** 100% payment against each order shall be made after receipt of the materials at site in full and good condition.
4. **Delivery:** Within 30 days from the date of placement of every formal order.
5. The quantities of the materials as indicated in the Annexure are only tentative and the same are liable to be change at the time of placement of the order.
6. The successful bidder shall not claim for any price enhancement during the validity period.
7. The successful bidder shall supply the materials against each order from the current stock. If the materials are found defective/ not as per specification the same materials shall be replaced free of cost to the Corporation. If the performance of the supply materials shall not found satisfactory the Corporation have the right to cancel the rate contract before expiry of the validity period.
8. **Submission of Bid:** The bid should be submitted in sealed envelope superscripted with "Tender against NIT No. KHEP/2013/192 to O/o the under mentioned by means of Registered post / by hand only.
9. The bids will be opened at the time and date mentioned below in presence of bidder or his authorized representative (if any). No electronic recording device will be permitted during opening of the bids.
 - i) **Last Date and Time of receipt of the bids :** 15-00 hrs of 30-10-2013
 - ii) **Date and time of opening of bids :** 15-30 hrs of 30-10-2013

In the case of any bandh / holidays on the above mention date, the bid will be received and opened in the next working day at the same time as indicated above. No telex / fax / Telegraphic tender will be received.
10. **Earnest Money Deposit:** The bidder is required to deposit an amount of ₹ 25,000/- (Rupees twenty five thousand) as security deposit in the form of Fixed deposit or Bank Draft on any Nationalized Bank, in favour of NEEPCO., payable at SBI, KHEPA, Garampani Branch, P.O.

Umrongso (SBI Code-4812) should be submitted along with the tender. Tender without EMD shall be rejected.

a. EMD submitted by the successful bidder shall be retained as Security Deposit and will be released only after expiry of 1 year validity period. If the successful bidder failed to supply during validity period, their EMD shall be forfeited.

b. EMD of the unsuccessful bidders will be returned only after finalization of the bid.

If the bidder withdraws the bid while it is under consideration, his EMD shall be forfeited.

11. All rates and amount of the bid shall be legibly written in both figure and words. In case of any discrepancy between figure and words, the amount indicated in the words will be considered.
 12. **Tender Fee:** Tender fee ₹1000.00 (non-refundable), in the form of Banker's Cheque / Demand Draft drawn in favour of NEEPCO Ltd. Umrongso, have to be submitted along with the quotation.
