Sealed two part tenders with minimum 120 (one hundred twenty) days validity are invited from reputed and experienced contractors for execution of the works **Erection & Commissioning under PHASE –I of Renovation and Modernization in Unit# 1 & 2 of 4 X 50 MW Kopili Power Station at Kopili Hydro Electric Plant., NEEPCO Ltd. Umrongso, Dima Hasao District, Assam.**

Qualifying Criteria:

1. The intending bidders must have experience in undertaking Erection & Commissioning Works or Renovation & Modernization Works of Hydro Turbine (Vertical Shaft Francis Turbine) Generator Unit of minimum capacity of 50MW.
2. Similar works should have been carried out by the intending bidder in the last 7 years and tenderer should have completed at least 3 similar works valued at ₹ 80.00 lakh each, or 2 similar works valued at ₹120.00 lakh each or 1 similar work valued at ₹ 160.00 lakh.
3. Average annual financial turnover during last 3(three) years, with year ending March 2013, should be at least ₹ 80.00 lakh.
4. Documentary evidence in support of the above must be submitted alongwith the bid.

The tenders should be submitted in two parts. The first part is with **Tender fee of ₹. 10,000.00** (Rupees Ten thousand) only, techno-commercial terms and conditions and **Earnest Money Deposit of ₹. 5,00,000/-** (Rupees Five Lakhs) only and second part is with price bid.
