NOTICE INVITING QUOTATION

Sealed Quotations with 120 (One hundred and twenty) days validity are invited from Manufacturer/Reputed Supplier for supply of (A) Crown Type Fountain, (B) Geyser Type Fountain to be installed at AGTP, NEEPCO Ltd., Ramchandranagar, Agartala, Tripura West.

Scope of Supply for (A) Crown Type Fountain:-

Supply of **1(one) Meter dia. (header)** Crown fountain along with supply of 6(six) numbers light fittings with lamps, colour sheets and sequencer for the above mentioned 6 Nos. light fittings.

01. We will not use submersible pump for this fountain. Monoblock pump will be used for the same. The capacity h.p./kw of the monoblock pump should be mentioned in the offer so that we can arrange correct pump for the same.
02. Installation will be done by us at our own cost.
03. As civil construction for the said fountain is already available with us, the bidder will have to supply only header without 4(four) numbers feed pipes which are connected with pump outlet.
04. A drawing along with Catalog of the product should be enclosed along with offer, failing which your quotation shall not be considered.
05. Diameter of the pipe to be used for this fountain should be mentioned in the offer. Numbers of nozzles to be used for this fountain should also be mentioned in the offer.
06. The sequencer should be capable to handle six numbers lights fittings (used for the above mentioned fountain).
07. If proper crown formation is not achieved, the bidder will have to rectify/replace the same at their own cost.

Scope of Supply for (B) Geyser Fountain:-

Supply of one number Geyser Type Fountain along with Supply of 3(three) numbers light fittings along with colour sheets and one number sequencer for above mentioned three numbers light fittings.

01. No stand pipe for fixing of geyser type fountain is needed for our case because this geyser type fountain will be placed inside a tank having diameter of 4(four) Feet.
02. As we are going to use monoblock type pump for the same, please mentioned the capacity h.p./kw of the pump.
03. No suction and delivery pipes are needed as these pipes are already installed.

Quotations shall be received till **15:00 hrs** of **18.11.2013** and shall be opened at **16:30 hrs.** of the same day. In case, **18.11.2013** happens to be holiday, offers shall be opened on the next working day at **16:30 hrs.**

NIQ No. & Opening date should be clearly superscribed on the sealed envelope of the quotations.

Terms & Conditions:

01. **Rates:** Rates should be quoted considering FOR at AGTP and all taxes. Bidders shall quote their rates legibly both in figures and in words. In case of discrepancy arises between figures and words, the price written in words shall prevail.
02. **Earnest Money:** Bidders will have to deposit Earnest Money along with the offer in the form of Call Deposit @ 2% (Two Percent) of quoted value from any Nationalized/Scheduled Bank pledged in favour of "North Eastern Electric Power Corporation Ltd."
03. **Payment Terms:** 100% Payment will be made after received of materials in full and good condition at our project site as well as after commissioning of the system at our project site.
04. **Delivery Period:** Delivery should be completed within 30 days from the date of issue of supply order.
