Sealed Quotations with 90 (Ninety days) validity are invited from the Manufacturer/Authorized Dealer / General Order suppliers for supply of '100% cotton clothing materials for stitching dungarees of personal working in Power House / Work-shop' of AGTP, NEEPCO:

## TERMS & CONDITIONS:

- **O1**. **SCOPE**: Supply, transportation, transit insurance, loading & unloading and delivery of the above mentioned items up to AGTP NEEPCO R.C.Nagar.
- **O2. SAMPLE**: Sample of the clothing material to be supplied must be enclosed with the submitted quotation, failing which their quotation shall not be considered.
- 03. OTHER PERTINENT POINTS:
  - i. Bidders to note that clothing materials suitable to our requirement shall be considered for evaluation. Name of the Mill from which manufactured is mandatory.
  - ii. Clothing material should be of fast colour and must be guaranteed against fading / shrinkage.
- **O4. DELIVERY & DELIVERY POINT:** All the materials shall be delivered within 45 (fourty five) days to the address of the consignee from the date of receipt of order.
- 05. LIQUIDITY DAMAGE: If the materials are not supplied within the stipulated time a Liquidity Damage shall be applicable @  $\frac{1}{2}$ %(half percent)of the total value of the undelivered items per week subject to a ceiling of 10% of the ordered value.
- O6. RATE: Bidder shall quote unit as well as total item wise prices for the materials. Rates should be quoted both in figure and words. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between "unit rate" and "total amount" the total amount evolved by multiplying the unit rate and quantity shall be considered.

The bidders shall fully make himself aware of the applicable taxes & duties for supply of goods at Tripura & submit total FOR destination prices showing break-up of basic price, applicable taxes & duties, freight & insurance charges. If no break-up is given, it will be considered that the quoted price is FOR destination price inclusive of all taxes & duties. In that case all the applicable taxes & duties levied during the supply of the material shall be borne by the supplier.

All prices shall remain firm till completion of the supply. For concessional CST, "C' Form shall be issued.

07. EARNEST MONEY: Rs. 400/- (Rupees Four Hundred) only to be submitted along with the offer in the form of Call Deposit/Demand Draft from any Nationalized Bank pledged in favour of North Eastern Electric Power Corporation Ltd., failing which their quotation shall not be considered. If a bidder withdraws the tender while it is under consideration or, after placement of order, the bid security /EMD shall be forfeited along with other action as the Corporation deems fit. The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder.

- O8. PAYMENT: 100% (hundred percent)payment shall be released after receipt of the materials in full and good condition and after necessary physical inspection at AGTP site, against submission of invoice in triplicate along with necessary documents. For effecting E- payment bidders to submit their Bank details for NEFT/RTGS.
- **O9**. **GUARANTEE**: The material should be guaranteed for its quality and should conform to the sample submitted while bidding. Any deviation would call for rejection
- 10. QUANTITY: Quantity may vary.
- 11. LAST DATE AND PLACE FOR SUBMISSION OF BID: The bidder shall submit their Quotation and EMD in a Sealed Envelope. These shall be received till 15:00 hrs. of 18-09-2014 at O/O the Sr. Manager (E)Store, AGTP, NEEPCO and shall be opened at 16:00 hrs. of the same day i.e. on 18-09-2014. In case 18-09-2014 is a holiday, the Quotation shall be opened on the next working day at 16:00 hrs.
- 12. All bids should be neatly typed out. Hand written bids / Quotations send by FAX & E-MAIL would not be accepted. Un-signed bids would not be considered.
- 13. The Bidder requested to note that participation in the bid shall be taken as acceptance of the terms & conditions as stated above. In case any condition(s) is/are not acceptable to the bidder, the same should be mentioned in the offer/quotation in clear terms.
- 14. If the bidder is eligible for any kind of exemption/concession from state Govt. /Central Govt. the bidder shall furnish documentary evidence to consider the same.
- 15. Deviations if any must be submitted as a separate attachment along with bid documents.
