- Scope of Work: The basic scope of work is topographical survey in Panior river from toe
  of the dam to 600m downstream of the dam on both banks upto EL 575m to obtain X section of the river, preparation of contour map and survey report of the area.
- 2. Technical Specification: The work shall be executed accordingly to the specifications and good standard of practice necessary to fulfill the objective of the Survey work, strictly in accordance with the instructions and satisfaction of the Engineer-in-charge. The specifications shall be read in conjunction with the description of the item in the schedule of item and price.
- 3. Maps & Submittals: The contour maps shall be in the scale of 1:500 with 2m contour interval and the X-section drawing shall be in the scale of 1:500 horizontal and 1:100 vertical. The survey grid of areas surveyed shall be tied up with latitude and longitudes. The surveyor shall furnish all field data and drawing in soft copy (on CD's) in ASCII and auto CAD format apart from 05(five) nos, hard copies.
