Sealed Quotations with 120 (One hundred twenty days) validity are invited from Manufacturer/Authorised Dealer / Reputed Govt. Supplier for supply of the items as shown in Annexure-A for Agartala Gas Turbine Power Plant, NEEPCO Ltd:

- A. Name of work : Supply of Consumables required for Major Inspection , U#4 of AGTP
- B. <u>PARTICULARS OF THE ITEM</u>: Particulars, specification and quantities of items to be supplied are as per "ANNEXURE-A".
- C. ESTIMATED VALUE: RS.3,94,000.00(RUPEES THREE LAKHS NINETY FOUR THOUSAND) ONLY.
- D. TERMS & CONDITIONS:
- 01. Scope: Supply, transportation, transit insurance, delivery, loading & unloading of items as detailed in "Annexture-A". Bidders should mention the make of offered materials wherever possible along with relevant IS specifications.
- **Delivery & delivery point**: All the materials shall be delivered within 45 (Forty Five) days to the address of the consignee from the date of receipt of the formal order.
- 03. Liquidity Damage: If the materials not supplied within the stipulated time a Liquidity Damage shall be applicable @ $\frac{1}{2}$ % (Half percent) of the total value of the undelivered items per week subject to a ceiling of 10% of the ordered value.
- **O4.** Rate: Bidder shall quote unit as well as total item wise prices for the materials. Rates should be quoted both in figure and words. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between "unit rate" and "total amount" the total amount evolved by multiplying the unit rate and quantity shall be considered.

The bidders shall fully make himself aware of the applicable taxes & duties for supply of goods at Tripura & submit total FOR destination prices showing break-up of basic price, applicable taxes & duties, freight & insurance charges. If no break-up is given, it will be considered that the quoted price is FOR destination price inclusive of all taxes & duties. In that case all the applicable taxes & duties levied during the supply of the material shall be borne by the supplier.

All prices shall remain firm till completion of the supply. For concessional CST, "C' Form shall be issued.

- O5. Earnest Money: An amount Rs. 7,900.00 (Rupees Seven Thousand Nine Hundred) shall be deposited as earnest money in the form of Call Deposit/ Demand Draft/ Bankers Cheque from any Nationalized Bank pledged in favour of North Eastern Electric Power Corporation Ltd., failing which their quotation shall not be considered. If a bidder withdraws the tender while it is under consideration or after placement of order, his bid security/EMD shall be forfeited along with other action, as the Corporation deems fit. The EMD shall be made payable without any condition to Purchaser .The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder.
- O6. Payment: 100% (hundred percent) payment shall be released after receipt of the materials in full and good condition and after necessary physical inspection and acceptance of the materials at our store, against submission invoice in triplicate along with all related document as required. For effecting E- payment you are requested to submit the bank details for NEFT/RTGS.

- 07. Guarantee/Warranty: All the materials quoted shall be guaranteed for their quality and during inspection if any material is found defective / substandard the same shall have to be replaced immediately after notice. Consumables which have self life must be from the current stock (i.e manufactured after 1st January 2014) only. For Markin cloth, sample must be submitted along with the offer. The items supplied in general must conform to the make indicated in Annexure-A.
- **07**. If the bidder is eligible for any kind of exemption/concession from state Govt. /Central Govt. the bidder shall furnish documentary evidence to consider the same.
- **08**. While submitting the bids the "check list for submission of bids" shall be strictly followed. Duly filled up copy of the same shall be placed along with the bids.
- 09. Last Date and Place for submission of Bid: The bidder shall submit their Quotation and EMD in a Sealed Envelope. These shall be received till 15:00 hrs. of 05.01.2015 at O/O the Sr.Manager (E) O&M, AGTP, NEEPCO and shall be opened at 16:00 hrs. of the same day i.e. on 05-01-2015. In case 05-01-2015 is a holiday, the Quotation shall be opened on the next working day at 16:00 hrs. Quotations send by FAX shall not be considered.
- 10. QUANTITY: Quantity to be ordered may vary.
- 11. If the bidder is eligible for any kind of exemption/concession from state Govt./Central Govt. the bidder shall furnish documentary evidence to consider the same.
- 12. All bids should be neatly typed out. Hand written bids / Quotations send by FAX & E-MAIL would not be accepted. Un-signed bids would not be considered.
- 13. The Bidder requested to note that participation in the bid shall be taken as acceptance of the terms & conditions as stated above. In case any condition(s) is/are not acceptable to the bidder, the same should be mentioned in the offer/quotation in clear terms.
- 14. Deviations if any must be submitted as a separate attachment along with bid documents.
