Sealed two part tenders with minimum 120 (one hundred twenty) days' validity are invited from reputed firms/ contractors for providing required number of unskilled, semi-skilled and skilled workmen for maintenance of 4x50MW Kopili Power Station at Kopili Hydro Electric Plant Umrongso, Assam.

Date and time for opening of techno-commercial bids: 15:30 hrs. of 30.05.2014

Earnest Money Deposit: ₹ 2, 00,000/- (Two Lakh) only. Tender fee: ₹ 5000.00 (Rupees Five thousand only)

Qualifying Requirements:

- i) The intending bidders must have experience in undertaking contracts for providing skilled / semiskilled / unskilled to PSUs/ Government organisations.
- ii) Similar works should have been carried out by the intending bidder in the last 7 years and bidder should have completed at least 3 similar works of contract value ₹ 40.00 lakh each, or 2 similar works of contract value ₹ 60.00 lakh each or 1 similar work of contract value at ₹ 80.00 lakh.
- iii) Average annual financial turnover during last 3(three) years, with year ending March 2013, should be at least ₹ 40.00 lakh.
- iv) Documentary evidence in support of the above must be submitted alongwith the bid.
- v) The bidder shall also submit the following documents in their bid in order to ensure qualification
 - a) Copy of PAN card.
 - b) Copy of Audited annual accounts for the last three years or extracts of the Bank Accounts of bidder containing transactions during last three years.
 - c) Latest Solvency and Credit facility certificates from their bankers.
 - d) Latest Service Tax Registration Certificate
