Sealed tender with minimum 120 (One twenty) days validity are invited from the manufacturers/ authorized dealers/supplier for supply and delivery of Nitrile Rubber make hose pipe as per technical specification, and quantity required for Kopili Power Station of Kopili Hydro Electric Plant , NEEPCO Ltd. ,Umrongso, Dima Hasao District , Assam .

a	It should be Oil Resistance & capable of withstanding of oil temperature up to 100 deg C
b	Quantity :- 3 (Three) nos
c	Pipe should be withstanding absolute vaccum without shrinkage.
d	Pipe should be steel wire braided at the centre of material through its length.
e	Pipe should be flexible for winding up easily for transportation and shifting conveniently.
f	Each hose pipe should be 20 meters long having ID of 40 mm.
g	Both end of each pipe should be connected with round brass flanges having OD of 106 mm and 4 holes of M -12 at 80 mm PCD.

a	It should be Oil Resistance & capable of withstanding of oil temperature up to 100 deg C
b	Quantity :- 3 (Three) nos
c	Pipe should be withstanding absolute vaccum without shrinkage.
d	Pipe should be steel wire braided at the centre of material through its length.
e	Pipe should be flexible for winding up easily for transportation and shifting conveniently.
f	Each hose pipe should be 20 meters long having ID of 25 mm.

Terms and Conditions:

- Bidder should state their Tax payer Identification Number, VAT Registration No. and PAN without which Bids may be summarily rejected.
- Authorized dealers should submit valid authorized dealership certificate along with the tender.
- Documentary evidence (supply order copy) regarding execution of supply orders for similar materials to Government / PSUs during the last three years have to be submitted along with the bid. Non-submission of copy of certificate or supply orders may result in disqualification.
- Price Basis:** The Price shall be quoted on FOR Guwahati basis indicating all charges towards freight and insurance and Taxes & Duties. All prices and rates shall be clearly indicated both in figures and words.
- Earnest Money Deposit :**EMD @ 2% of quoted value in the form of DD duly pledged in favour of NEEPCO Ltd. , Umrongso (SBI branch code: 4812) should be submitted along with the tender. Tenders without EMD shall be summarily rejected.
 - EMD submitted by successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released only after delivery of the entire quantity of the valves to the satisfaction of the Corporation.
 - EMD of all unsuccessful bidders will be returned only after finalization of the bid.
 - If the bidder withdraws the bid while it is under consideration, his EMD shall be forfeited along with other action as per norms of the Corporation.
- Delivery Period:** The materials shall be delivered at site within 8 (eight) weeks from the date of issue of order.

7. **Guarantee / Warranty :**
- 7.1 The hose pipe to be supplied shall be warranted / guaranteed as per manufacturer's norms or for a period of 12 months from the date of despatch against manufacturing defect/ defective workmanship.
- 7.2 The successful bidder shall supply the pipe to the satisfaction of the consignee. Defective items shall be replaced by the supplier at free of cost immediately on intimation from this end.
8. **Payment:** a) 100% payment inclusive of all taxes and duties shall be made on receipt of the materials at site in full & good condition and against submission of bill.

9. **Submission of Bid:**
- 9.1 The duly signed bid should be submitted in sealed envelope superscribed with "Tender against NIT No. KHEP/C&P(E)/2014/209 dtd.25.08.2014" to O/p the Sr. Manager (E), C&P, KHEP, NEEPCO Ltd, P.O.Umrongso, Dist:-Dima Hasao, Assam, PIN-788931, by means of registered post or in person only under the bidder's letter head with details like complete address, telephone/ fax no., dealing person etc. so as to reach at this end on or before the due date. Offer received through fax / mail / etc. shall not be acceptable.
- 9.2 A signed copy of the tender specification (detailed NIT) must be submitted along with the bid in acceptance of NIT conditions.
- 10 The bids will be opened at the time and date mentioned below in presence of authorized representative (if any) of the bidders. No electronic recording device will be permitted during opening of the bids.
