Documentary evidence in support of experience must be submitted along with the bid.
- 2. The bidder should have sound financial capacity to accomplish the work of required specifications and shall have average annual turnover of at least Rs. 15 Lakh only during the last three years, ending 31st March of the previous financial year.
- 3. Bidder shall submit copy of audited annual accounts for the last three financial years.
