The North Eastern Electric Power Corporation Limited (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India invites Single-Stage Two Envelope Bids from a reputed manufacturer for Design, Engineering, Manufacture, Packing and forwarding, Supply, Transportation to site, Insurance from the source of supply till commissioning, Installation, Testing and Commissioning of 220Volts, 600AH Plante Lead Acid Stationary Type Battery Bank comprising of 110 Nos. batteries of 2Volts,600AH each along with 4 nos. of spare cells, suitable inter row/tier connectors and steel battery stand and buy back of old 110 Nos, 2V, 600AH batteries.

1. QUALIFYING REQUIREMENTS

1.1 Technical

- (i) Bidders must be a reputed manufacturer and must have experience in Design, Engineering, Manufacture, Packing and forwarding, Supply, Transportation to site, Insurance from the source of supply till commissioning, Installation, Testing and Commissioning of 220Volts, 600AH Plante Lead Acid Stationary Type Battery Bank or similar ratings to power stations or sub-stations of any Government/Public Sector Undertaking. They shall furnish at least 3(three) copies of orders placed on them for Supply, Installation, Testing and Commissioning of battery bank of similar ratings during last 3(three) years prior to the date of publication of the Notice Inviting Bids. Performance/Completion Certificates/evidence issued by respective authority against these orders shall also be submitted by the bidders.
- (ii) The bidder should not have been blacklisted by any Government/Government agency in India. Self declaration to that effect should be submitted along with the bid.
- (iii) The bidder shall submit the notarized copy of valid License/ permit for manufacturing of Battery.

1.2 Financial

- (i) **Minimum Average Annual Turnover** in the best 3(three) financial years out of the last 5(five) financial years, ending 31st March of the previous financial year, should not be less than INR **3,95,40,000.00** (Rupees three crores ninety five lakks forty thousand only).
- (ii) The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than INR. 54,91,000.00 (Rupees fifty four lakhs ninety one thousand) only. The Certificate of Banker regarding the availability of unutilized credit facilities shall not be dated earlier than 30 (thirty) days prior to the date of opening of bids. Liquid Asset = Current Asset (Inventory + Pre-Paid expenses)

iii) Net Worth:

Net worth of the bidder as on last day of the preceding financial year, ending 31st March of the previous financial year should not be less than 50% of the paid up share capital. The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit and Loss Account less (a) Expenses not written off (b) Loss in Profit & Loss Account if not reduced from Reserves.

iv) **Bid Capacity:**

The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than the estimated cost of the work put to tender:

Bid Capacity = $A \times N \times 2 - B$, where,

A = maximum value of works executed in any one year during last 7 (seven) years (at current price level).

N = Completion time of the proposed work in years.

B = Value at current price level of existing commitments and on going works to be completed during next N years.

Bid capacity shall be assessed at the time of submission of Techno-Commercial Bid, for which the bidder shall have to submit documentary evidence in support of "A" & "B" above along with their Bid.

2. Copies of Audited Balance Sheet & Profit and Loss account for the last 3(three) financial years certified by a Chartered Accountant indicating the Annual financial turnover and latest Banker's

Certificate in support of solvency shall be furnished along with latest and valid VAT Registration Certificate/number.
