The undersigned on behalf of "North Eastern Electric Power Corporation" (NEEPCO) (hereinafter referred as the Purchaser) hereby invites Sealed tender under single bid system with a validity of 180 (One Hundred Eighty Days) from authorized dealer/distributor/manufacturer for supply of the water supply pipes & fittings items to Ranganadi H.E. Plant as per the terms & conditions are detailed herein under:

- 1. Name of the work: "Supply of Water Supply Fittings to Ranganadi H.E. Plant".
- 2. Scope: The scope of the work is the 'Supply of Water Supply Fittings to the Central Store of Ranganadi H.E. Plant, NEEPCO Ltd. Yazali, Arunachal Pradesh, as per Specification and Make mentioned in the schedule of item enclosed as Annexure A.

3. Qualifying Criteria:

The Qualifying criteria of the bidder are given as follows:-

- The firm shall be a valid authorized dealer /distributor / Manufacturer for supply of the water supply items.
- (ii) The firm shall submit a Solvency Certificate for an amount to ₹. 3,00,000.00 issued by a Nationalized/ Scheduled Bank.
 - The firm shall possess a valid registration certificate under Sales Tax Registration. (iii)
 - The firm shall possess valid PAN Card. (iv)

The bidder shall submit relevant documents in support of the qualifying criteria failing which his bid would be deemed incomplete and shall be rejected.

4. Bidding Procedure:

- a) The bidder shall submit bid documents under the Single-stage bidding system detailed as follows:
 - The bid document along with all the relevant documents shall be submitted in one i) envelope. The envelope shall be super scribed with the NIQ No. and also indicate the name and the complete address of the participating bidder.
 - The Bidder shall submit Earnest Money Deposit (EMD) as indicated under Clause ii) no 14 of this NIQ along with the bid document.
 - The price bid shall be indicated separately in the prescribed format of the bid iii) document.
 - The complete filled up detailed Bid documents shall be submitted personally or by iv) registered post to the Sr. Manager (E/M) C&P, RHEP, NEEPCO, Yazali, Lower Subansiri. Dist, Arunachal Pradesh 791119, Phone No 03809-222206 (O) within the appointed date and time as indicated.
 - Down loaded bids should be accompanied with the cost of bid Document other V) wise the same shall be rejected.

- b) The bidder should ensure that all pages of the Bid Document bear the seal and signature of the participating bidder.

5. Rate per unit basis:

- **5.1.** Rate for the scope of supply of respective item against specification shall be "FIRM" till completion of supply irrespective of any quantity variation either upward or downward, i.e. Plus or Minus. No escalation of the rates quoted will be admissible.
- 5.2. Bidders are to quote unit rates in numerical figures and words for the items indicated in Annexure-I. The tendered amount shall be legibly written in English in ink, in Indian currency both in numerical figures and words. In case of any discrepancy between figures and words, the rates in words will govern and considered for evaluation and subsequent placement of supply order. Erasing, over writing, changes and cuttings shall be initialed by the bidders.
- 5.3. Taxes, Duties & Levies: Bidders shall quote their rates against respective item specification inclusive of all Packing and Forwarding charges, Transportation & Insurance Charges. All other taxes and duties like Excise duty, CST, Entry tax (wherever applicable) should be indicated separately in the prescribed format given as Annexure A. No extra charge on this account shall be paid by the corporation. The Corporation shall treat the quoted rates as final and inclusive of all components & taxes etc. For Supplier outside the state of A.P., the requisite Entry Tax @ 12.5 % on the total amount has to be paid be the supplier, which is to be indicated separately. However, the supplier has to submit the documentary evidence for depositing the Entry Tax along with the final bill failing which the bill shall not be released.
- 5.4. All the rates to be quoted for 'FOR NEEPCO Ltd. Yazali, A.P' basis.

6. Exemption to Small Scale Industries;

Statutory exemptions for participating bidders registered under Small Scale Industries as per the Government of India Guidelines/ Norms shall be considered on production of relevant documents.

7. Payment Terms:

7.1. 90% (ninety percent) Payment will be released on receipt of all the materials in full and good condition and after inspection by the Consignee. Remaining 10% will be kept as Performance Guarantee which will be released after 6 months from the date of completion of the supply or 3(Three) months from the date of successful installation of pipes/ fittings, whichever is earlier. No part payment/advance payment will be entertained.

- 7.2. 100% (Hundred percent) Payment will be released on receipt of all the materials in full and good condition and after inspection by the Consignee on submission of Bank Guarantee amounting to 10% of the Contract value prior to the release of the bill. The Bank Guarantee will be kept as Performance Guarantee which will be released after 6 months from the date of completion of the supply or 3(Three) months from the date of successful installation of pipes/fittings, whichever is earlier. No part payment/advance payment will be entertained.
- 8. <u>Paying Authority</u>: The paying authority shall be Sr. Manager (F), F&A wing, RHEP, Yazali, L. Subansiri District, Arunachal Pradesh.
- 9. Consignee: The Consignee shall be Sr. Manager (E), S&T, RHEP NEEEPCO Ltd.
- **10.** <u>Time of Completion</u>: The supply shall be completed within 60(Sixty) days from the date of issue of the Order.

11. Compensation for Delay:

In case of delay in supply of items after the stipulated period indicated in clause no.10 above, compensation for delay at the rate of ½%(half percent) of the contract price shall be deducted for per week or part thereof of delay subject to a maximum of 10%(Ten percent) of the contract price. However, the Purchaser reserves the right not to accept the delayed items and cancel the order depending upon the discretion of Competent Authority.

12. Security Deposit:

A security deposit of 10% shall be deducted, which shall be released after completion of Inspection by Engineer – In – Charge or 03(three) months from the date of completion of supply, which ever is earlier. Any defect in the supply, detected after the completion of the supply or during inspection, shall be replaced by the Supplier at his own risk and cost, and no extra payment shall be made by the corporation. The nature and extent of defects to be considered for the purpose of Defect Liability, shall be decided by the Head of Project/EIC and decision of Head of Project/EIC in this matter shall be final and binding.
