### **NOTICE INVITING TENDER**

Sealed single part Tender with minimum 120 (One hundred & twenty) days validity are invited from the experienced/reputed suppliers for supply of **Stud, Nut , Bolts & Washers** for Ranganadi Power House, NEEPCO Ltd. , Yazali, Arunachal Pradesh as per specification & quantity enclosed at **Annexure-A** , drawing at **Annexure-B** and terms & conditions indicated below.

#### **Terms and Conditions:**

1. The Tender should be submitted in Sealed Envelope super scribed with

(i) "NIT FOR SUPPLY OF STUD, NUT , BOLTS & WASHER " against NIQ No.: RHEP/ PH&SY(O&M)/04/ 14-15, Dtd. 07.01.2015

(ii) Date of Opening: 28.01.2015

- **2.** The bidders shall have experience of executing similar types of supply to any PSU / Govt. organisation in last 2-3 years. In support of this, bidders should submit copy of such supply orders along with their quotation. Quotations without this evidence shall be summarily rejected.
- **3.** Bidder should submit self attested copy of their Tax payer Identification Number, Tax/VAT Registration, Service Tax Registration and PAN Card as applicable.
- **4.** Authorized dealers should submit valid authorized dealership certificate along with the Tender.
- **5. Price Basis**: The Price shall be quoted on FOR project site basis i.e. Dikrong Power House, Ranganadi HE Plant, Hoj, Papumpare Dist., Arunachal Pradesh. The rates for Taxes & Duties, if any, should be separately and clearly indicated in the Tender. The rate shall be indicated both in figures and in words.
- **6. Earnest Money Deposit :** EMD amounting ₹ 7,900.00 (Rupees Seven Thousand Nine Hundred) only in the form of Demand Draft/ bankers Cheque duly pledged in favour of Ranganadi H E Plant, NEEPCO Ltd , Yazali (SBI Yazali branch (RHEPA) code: 9917) should be submitted along with the Tender. Tender without EMD shall be summarily rejected.
  - i) EMD submitted by successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released only after delivery of the entire quantity of the material to the satisfaction of the Corporation. If successful bidder fails to execute the order then EMD shall be forfeited by corporation.
  - ii) EMD of all unsuccessful bidders shalll be returned only after finalization of the bid.
  - (iii) Following units are however, exempted from payment of EMD:
    - a) Public Sector Enterprises
    - b) Units registered with National Small Industries Corporation (NSIC) subject to :
      - The unit being registered with NSIC for the item tendered.
      - Registration certificate being valid as on date of quotation.

As the case may be, the bidders must submit documentary evidence against PSE or a valid NSIC Registration Certificate.

**7. Payment:** 100% (hundred percent) payment shall be made after receipt of material at site in full & good condition.

- **8. Delivery Period:** The delivery of the materials shall be completed within 45 (forty five) days from the date of issue of order.
- **9. Liquidated damage:** In case of delay in supplying on part of supplier after schedule delivery period, LD @ 0.5% per week of delay subject to a maximum of 5% of the contract value shall be applicable subject to force majeure.

#### 10. Guarantee / Warranty:

- (i) The material supplied shall be warranted / guaranteed against any manufacturing defect/ poor workmanship for a period of 12 months from the date of receipt of materials.
- (ii) The successful bidder shall supply the materials to the satisfaction of the Consignee/ Engineer-in charge. If the materials supplied are found defective, the same shall be replaced by the supplier without any additional cost to the Corporation immediately on intimation from this end.
- **11**. **Taxes & Duties**: Taxes and duties, if applicable, should be indicated clearly.
- **12. Technical Specification:** The material shall be as per technical Specifications enclosed at Annexure-A (schedule of prices) & drawing Annexure –B.
- 13. Submission of Bid: The tender in sealed envelop may be submitted to the office of the undersigned in person or by any authorized representative of the bidder or by means of registered post and must be submitted only under the bidder's letter head with details like complete address for communication, telephone/ fax no., name of contact person etc. so as to reach at this end on or before the due date. Offer received through fax / mail / telegram etc. shall not be acceptable. The bidders shall sign each pages of this NIT document in support of acceptance of terms & conditions of NIT and submit along with the Tender.
- **14.** The Quotations shall be opened at the time and date mentioned below in presence of authorized representative (if any) of the bidders. In the event of holiday, the quotation will be received & opened at the same time in the next working day.

- **16.** Bids received later than the prescribed due date shall not be considered in any circumstances.
- **17**. The language and currency applicable are English and Indian currency respectively & shall be legibly written. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between unit rate and total amount, the total amount evolved by multiplying unit rate and quantity shall be considered.
- **18.** The quantity of the material to be supplied as mentioned in the NIT is indicative and is liable to change during the time of placing the order.
- **19.** Any action on the part of the bidder to revise the price or to change the structure of the price at his own instance after opening of the bid and within the validity of the offer shall not be acceptable.
- **20.** The Corporation does not bind itself to accept the lowest tender and reserves the right to reject any or all tenders without assigning any reason thereof in the interest of the Corporation.
