The Bid should be submitted in a single envelope super-scribed clearly as "Quotation for 3.5 Core x 400 Sq.mm Aluminum un-armored PVC/XLPE insulated cable in NEEPCO AGTP CC EXTENSION PROJECT " Against **NIQ no 05** dtd 05-09-2014

Scope: Supply, Transportation, Transit insurance, Delivery, Loading & Unloading of 3.5 Core x 400 Sq.mm Aluminum un-armored PVC / XLPE insulated cable in NEEPCO AGTP CC Extension project as mentioned below:

- 1. **Delivery & Delivery point**: All the materials shall have to be delivered within 45 (Forty Five) days from the date of issue of formal order to the address of the consignee.
- 2. **Transit Insurance**: In Supplier's Account.
- 3. **Liquidity Damage:** Shall be applicable @ 0.5% (half percent) of the total value of the undelivered items per week subject to a ceiling of 10% (ten percent) of the ordered value. However, LD clause shall not be applicable in case of Force Majure condition like riots, flood, acts of war, invasion, hostilities or natural calamity or act of God.
- 4. **Rate:** Bidder shall quote prices (on FOR AGTP basis) both in figure and words. In case of any discrepancy rate quoted in words shall be considered. Quoted Rates shall Remain FIRM and FINAL till the completion of supply.
- 5. The bidders shall make themselves fully aware of the applicable taxes & duties for supply of goods at Tripura & shall <u>quote total FOR destination prices</u> showing detail break-up of basic price, applicable taxes & duties, freight & insurance charges. For concessional CST, "C" Form shall be issued.
- 6. **Earnest Money**: @ 2.5 % (Two & half) percent of quoted price shall be deposited as earnest money in the form of a Call Deposit/Bank Guarantee (B.G.) from any Nationalized / Scheduled Bank pledged in favour of M/s North Eastern Electric Power Corporation Ltd. The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder. The bid without EMD shall not be accepted.
- 7. **Payment:** 90% (Ninety percent) payment along with 100 % (Hundred percent) taxes and duties shall be paid after receipt of materials **in full and good condition** at AGTP store and balance 10% (ten percent) shall be paid after expiry of warranty period. ED, if applicable, shall be paid on production of documentary evidence.

<u>Alternatively</u>, 100% (Hundred percent) payment shall be released on submission of B.G. for an amount equivalent to 10% (ten percent) of billed amount; with validity for 12 (Twelve months). The BG should be issued from a Nationalised / Scheduled Bank in India.

Bill in triplicate should be submitted to the consignee along with all relevant documents like Delivery Challan, Copy of LR, Factory Test Certificates, etc along with bank details for effecting payment.

- 8. **Exemption**: If the bidder is eligible for any kind of exemption/concession from state Govt./Central Govt. they will furnish documentary evidence to consider the same.
 - In case any prospective MSE bidder intends to participate in the bidding process, he must submit all documentary evidence in support of his MSE status from competent authority so as to avail the benefits as per Govt guidelines.
- 9. **Warranty / Guarantee:** The material should be guaranteed / warranted against any manufacturing defect and satisfactory performance for a period of 12 (Twelve) months from the date of receipt at AGTP store.
- 10. **Test certificate:** The supplier must enclose the factory test reports during execution of the supply.
- 11. Last Date and Place for submission of Bid: The bidder shall submit their Quotation and EMD in a Sealed Envelope. These shall be received till 15:00 hrs. of 27-09-2014 at O/o the Dy General Manager (E/M) AGTP CCEP, NEEPCO and shall be opened at 16:00 hrs of the same day i.e. on 27-09-2014 In case 27-09-2014 is a holiday, the Quotation shall be opened on the next working day at 16:00 hrs. Quotations received through FAX shall not be considered. The bidder or his authorised representative may remain present during the bid opening. No Documents shall be accepted after the last date/time of Receipt of Tender and NEEPCO shall not remain responsible for any delay in submission and receipt of the Bid.
- 12. The bidders are requested to note that participation in the bid shall be taken as acceptance of the terms & conditions as stated above. In case any condition(s) is/are not acceptable to the bidder, the same should be mentioned in the offer/quotation in clear terms.
- 13. **Deviations if any** from the tender requirements must be reflected in a separate sheet.
- 14. The Bidder or his authorised representative shall sign each and every page of the bid document and enclosures. Un-signed bids / documents would not be considered. All bids should be neatly typed out. Hand written bids would not be accepted.
