- 1. The bidders are to make aware of the type of filters required for quoting and may make a visit to the plant prior to submitting their quote. They must be confident that their product is suitable for the equipment and are to substantiate their claim that the product quoted are in use and compatible to Franke Make Oil Mist Separator which is in service for 21 MW GE make Frame-V Gas Turbine. More over they are to submit a sample of their product while quoting.
- 2. Pressure Drop: a). Clean and dry : To be specified along with Test Reports
  - b). Clean and saturated: To be specified along with Test Reports
- 3. Quantity may increase or decrease.
- 4. Bidders are to specifically mention regarding tests to be carried out on readiness of the materials in presence of NEEPCO representative.
- 5. Bidders to submit latest performance certificate of similar type filters in the last six months failing which their bids would not be accepted.

#### D. TERMS & CONDITIONS:

- **O1**. **Scope**: Supply, arrangement of transportation, transit insurance, loading & unloading of item and delivery up to AGTP Warehouse.
- **O2. Delivery & delivery point**: All the materials shall be delivered within 45 (Fourty Five) days to the address of the consignee from the date of receipt of the formal order.

Liquidity Damage: If the materials not supplied within the stipulated time a Liquidity Damage shall be applicable @  $\frac{1}{2}$ % (Half percent) of the total value of the undelivered items per week subject to a ceiling of 10% of the ordered value.

Rate: Bidder shall quote unit as well as total item wise prices for the materials. Rates should be

quoted both in figure and words. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between "unit rate" and "total amount" the total amount evolved by multiplying the unit rate and quantity shall be considered. The bidders shall fully make himself aware of the applicable taxes & duties for supply of goods at Tripura & submit total FOR destination prices showing break-up of basic price, applicable taxes & duties, freight & insurance charges. If no break-up is given, it will be considered that the quoted price

levied during the supply of the material shall be borne by the supplier.

All prices shall remain firm till completion of the supply. For concessional CST, "C' Form shall be issued.

- Earnest money: An amount Rs. 7,800.00 ( Rupees Seven Thousand Eight Hundred) shall be deposited 05. as earnest money in the form of Call Deposit/ Demand Draft/ Bankers Cheque from any Nationalized Bank pledged in favour of North Eastern Electric Power Corporation Ltd., failing which their quotation shall not be considered. If a bidder withdraws the tender while it is under consideration or after placement of order, his bid security/EMD shall be forfeited along with other action, as the Corporation deems fit. The EMD shall be made payable without any condition to Purchaser .The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder.
- Payment: 90% (ninety percent)payment shall be released after receipt of the materials in full and good 06. condition and after necessary physical inspection and acceptance of the materials at our store, against submission invoice in triplicate along with all related document as required. Balance 10% shall be released after expiry of warranty period. 100% (hundred percent) payment would be OR against submission of Bank Guarantee (BG) in enclosed NEEPCO format from any scheduled/Nationalised Bank for equivalent amount of 10% with validity for 18 (Eighteen ) month from the date of receipt of the materials . For effecting E- payment you are requested to submit the bank details for NEFT/RTGS.
- 07. Guarantee: The material should be guaranteed for any manufacturing defect and satisfactory performance for 18 (eighteen) months from the date of despatch of materials or 12(twelve) months from the date of commissioning, whichever is earlier. If any material is found defective or substandard and does not conform to the specific requirement as detailed above at the time of inspection of materials at store on receipt the same shall be liable for rejection.
- 08. If the bidder is eligible for any kind of exemption/concession from state Govt. /Central Govt. the bidder shall furnish documentary evidence to consider the same.
- 09. While submitting the bids the "check list for submission of bids" shall be strictly followed. Duly filled up copy of the same shall be placed along with the bids.

In case 08-01-2015 is a holiday, the Quotation shall be opened on the next working day at 16:00 hrs. Quotations send by FAX shall not be considered.
- 12. QUANTITY: Quantity to be ordered may vary.
- 13. If the bidder is eligible for any kind of exemption/concession from state Govt./Central Govt. the bidder shall furnish documentary evidence to consider the same.
- 14. <u>All bids should be neatly typed out. Hand written bids / Quotations send by FAX & E-MAIL</u> would not be accepted. Un-signed bids would not be considered.
- 15. The Bidder requested to note that participation in the bid shall be taken as acceptance of the terms & conditions as stated above. In case any condition(s) is/are not acceptable to the bidder, the same should be mentioned in the offer/quotation in clear terms.
