### **Scope of Work:**

The scope of this work shall be supply and successful installation of the prescribed number of computers, printers and UPSs as per specifications at Tuirial Hydro Electric Project site in Mizoram.

#### **Terms and Conditions:**

- 1. The bidder must be required to deposit earnest money @ 2% (1% for SC/ST) of the quoted amount in the form of Call Deposit or Term Deposit only. No tender shall be accepted without the earnest money.
- 2. The bidder should invariably submit his tender in a sealed cover. The bid will contain the following:
  - (a) Details of bidder as per prescribed format.
  - (b) Detailed specifications of the computers, printers and UPSs, separately for each item. The specifications should preferably be accompanied by printed leaflets/brochures etc., if any, from the concerned brand/company.
  - (c) Latest sales tax clearance certificate.
  - (d) VAT, GST and CST registration numbers.
  - (e) **Earnest Money:** Earnest money deposit @ 2% (1% for SC/ST) of the quoted amount in the form of Call Deposit or Term Deposit drawn in favour of "NEEPCO Ltd."
- 3. Price (rate) of the items per unit.

#### 4. Payment:

- (a) 90% payment will be made directly to the bank account of the supplier after completion of supply and successful installation of all the items at site and within 15 (fifteen) days from the date of receipt of bill. The supplier shall submit bills in triplicate along with bank account details (account number, bank name, branch code, IFSC code, etc.) for effecting payment directly to his account.
- (b) 10 % of the billed value will be kept as security deposit, which will be released after successful performance of the items for one year from the date of installation at site.
- 5. **Validity**: The rates should be valid for a period of 120 (one hundred twenty) days from the date of opening of bids..
- 6. Rate quoted must be inclusive of all taxes and duties. Rates shall be in Indian rupees, shall be firm and fixed.
- 7. All essential and standard items including power cables, data cables, connectors, etc. for each type of item shall be assumed to have been included in the quoted price. The bidder must ensure that all the items (computers, printers, UPS) are supplied with required Driver Software in the form of CDs/DVDs.
- 8. Installation of the items supplied must be done by the supplier at the site without charging any extra cost to the Corporation.

- 9. Bidders having dealership of the quoted brand(s) have to attach copy of authorized dealership certificate from the company. The original certificate must be produced at the time of opening of bids or as and when asked for.
- 10. **Delivery**: Items must be delivered within 21 days from the date of issue of order.

- 12. **Warranty:** The items must be under warranty for a period of not less than one year. **The vendor must specifically and clearly mention the warranty period for each item.** During the warranty period, if any defect/malfunction of the items are noticed and informed to the supplier, the supplier shall rectify the same or replace the defective item free of cost at the purchaser's site at the earliest possible time, latest by within a period of 15 days of notification.
