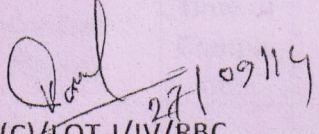
Tender not accompanied by the requisite EMD shall be rejected. If the Tenderer withdraws his tender during the tender validity period, the EMD shall be forfeited.

The earnest money of unsuccessful bidders shall be released on finalization of the tender.

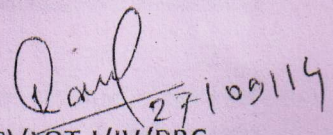
