## **TERMS AND CONDITIONS:-**

- 1. The Rate should be quoted legibly and clearly both in figure and in words and should be inclusive of all taxes and duties except Service Tax which shall be reimbursed extra for service providers part, if applicable, subject to submission of requisite paid Challan. The quoted rate should be inclusive of all taxes and duties except Service Taxes which shall be paid extra at actual for service providers' part against submission of documentary evidence.
- Scope of Work; The vehicle shall be utilized for services of NEEPCO on 12 (twelve) hours duty in a day basis by the designated officer or officials within Tripura Gas Based Power Project or outside Tripura(Assam/Meghalaya / Mizoram) as per requirement of work as may be decided by the Project authority of TGBPP.
- Per KM Charges quoted shall be inclusive of cost of requisite POL as the POL consumed during running of the vehicle shall be provided by the supplier at his cost.
- 4. The per day hire charge and per KM charges are to be quoted separately.
- 5. Rates for Night halt charge within the station/outstation shall be quoted separately.
- 6. The vehicle shall on duty for 12(twelve) hours in a day.
- 7. H.Q of the vehicle shall be at Project Site ,NEEPCO Ltd, Monarchak, Sonamura, District –Sepahijala (Tripura).
- Night halt charges shall be admissible as per rate for halt- age outside of H.Q i.e Project Site, TGBPP, Monarchak or outside of Tripura. Merely parking the vehicle in Agartala beyond duty hours will not make the vehicle entail for night halt charges.
- Period of Contract; The initial contact shall be for a period of 3 (three) years, subject to satisfactory performance /service of the vehicle and/or the Driver.
- 10. Boarding, Lodging and salary including monthly deposition of Provident Fund to the concerned authority if already registered under EPFO etc. of the Driver shall be the responsibility of the Supplier.
