The North Eastern Electric Power Corporation Limited (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India invites applications through online single stage two part bidding system under Domestic bidding route for LAN equipment at the following locations given below.

1. QUALIFYING REQUIREMENTS FOR BIDDERS

1.1 Technical

1.1.1 The bidder should be an Original Equipment Manufacturer (OEM) or Authorized System Integrator/ Authorized Vendor of the OEM, who must have supplied and successfully installed and commissioned at least 3 (three) similar LAN Equipment as specified in the Schedule of System Requirements, Section IV of the bid document, in any Public Sector Undertaking / Government (Either Central or State Government) Organization or in any reputed organization in India of value of at least Rs. 20 Lakhs (Rupees Twenty lakhs) each during last 7 (seven) years. The bidder should furnish copies of the Completion

- certificate with detailed Orders and also Performance Certificates from the customers, which should indicate the dates of successful commissioning and operation of the system.
- 1.1.2 In case of being Authorized System Integrator/ Authorized Vendors of the OEM the Bidder should enclose Authorization Letter(s) from OEM (s) addressed to NEEPCO mentioning the tender enquiry number. The person signing the Authorization letter should be duly authorized by the respective OEM.
- 1.1.3 Bidder should have a full-fledged Authorized Service Set-up/Service Centre(s) in North East, India. Details of such Authorized Service Set-up/ Service Centre(s) indicating complete address and contact details shall have to be furnished. In case service is rendered through Authorized Partner, the bidder shall furnish a certificate indicating the same and the place of Service set-up/Service Centre(s) of the partner.
- 1.1.4 The bidder shall not have been blacklisted by any Government/ Government agency in India. Self declaration to that effect should be submitted along with the technical bid.

1.2 Financial

(a) Minimum Average Annual Turn Over (MAAT):

The average annual turnover of the bidder in the best 3 (three) financial years out of the last 5 (five) years financial year should not be less than Rs. 161.00 lakhs (Rupees One hundred sixty one Lacs only). Other income will not be considered for arriving at annual turnover.

(b) Net Worth:

The Net Worth of the bidder as on last day of the preceding financial year shall not be less than 50% of the Paid up Share Capital.

The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit & Loss Account Less (a) Expense not written off (b) loss in Profit and loss Account if not reduced from Reserves.

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 5(five) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

(c) Liquid Assets:

The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than Rs. 54.00 lakhs (Rupees Fifty Four lakhs only).

The certificate of the Banker regarding the availability of unutilized credit facility should not be dated earlier than 30 (thirty) days prior to the date of opening the bid.

(d) Bid Capacity:

The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than the estimated cost of the work put to tender:

Bid Capacity = $A \times N \times 2 - B$, where,

- A = maximum value of works executed in any one year during last 7 (seven) years (at current price level).
- N = Completion time of the proposed work in years
- B = Value at current price level of existing commitments and ongoing works to be completed during next N years.

Bid capacity shall be assessed at the time of submission of Technocommercial Bid, for which the bidder shall have to submit documentary evidence in support of "A" & "B" above along with their Bid.

2. Interested bidders who fulfill the qualifying requirement as mentioned at 1.1 & 1.2 above may download the bid documents from http://neepco .abcprocure.com with on vendor registration as detailed below.

3. Portal Registration:

The bidders intending to participate in the e-tendering and to download the detailed bid document have to register themselves in the portal https://neepco.abcprocure.com. Relevant information about the bidder required during the registration is available in the portal.

4. Vendor registration fee:

The fees for Vendor Registration in the portal is INR 3000.00(Rupees three thousand) only per year. (Non refundable)

After payment of vendor registration fee, the scanned copy of payment receipt should be sent along with the bidders' details at email id: contract@neepco.gov.in to advice the service provider for approval of the Vendor.

If a vendor is already registered and going to participate in the tender, the vendor is to ensure that his registration in the system is valid till the completion of the entire bidding process.
