Bidders shall quote their rates legibly in both in figures and in words. In case of discrepancy arises between figures and words, the price written in words shall prevail. "However, the rates of Chemicals shall not change/vary during the delivery period of supply and until the final delivery of total supply".
- 02. Quantity: Quantity may increase or decrease.
- 03. Delivery period:

Materials must be delivered within 30(thirty) days from the placement of supply order. Items shall be supplied in two installments based on purchaser's requirement during the supply period of one (01) year. There shall not be any change in the price till final delivery of supply within a period of 01(one) year, as already mentioned at serial 01 above.

- 04. **Earnest Money**: Bidders will have to deposit Earnest Money along with the offer in the form of Call Deposit / Fixed Deposit @ 2% (Two Percent) of quoted value from any Nationalized/Scheduled Bank pledged in favour of North Eastern Electric Power Corporation Ltd.
- 05. **Test Certificate:** The supplied chemicals should accompany necessary Test Certificate from Govt. /Registered Lab.
- 06. Payment Terms: 100% payment shall be released on receipt of the materials in full & good condition at AGTP, NEEPCO Ltd., Ramchandra Nagar, Agartala, Tripura (West).
- 07. Liquidity Damage: Liquidity Damage shall be applicable @ ½ % (half percent) of the total value of the incomplete supply of materials per week subject to ceiling of 10% of the ordered value.
- 08. Qualification & Experience:

Experience of having successfully completed similar nature of supply during last 7 (Seven) years should be enclosed with the quotation.
