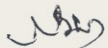
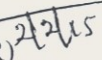


**SHORT NOTICE INVITING TENDER**

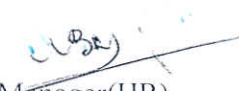
(4) Tender received without the EMD/Bid Security shall be liable for rejection.
