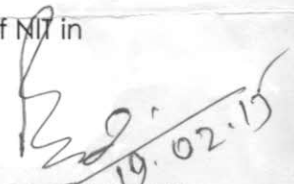

1. **ESSENTIAL CONDITION:** The works shall include supply of "CHLORINE SAFETY EQUIPMENTS" as detailed in Technical Specifications and prices shall be quoted accordingly. The purchaser reserves the right to accept lowest rate for total system as package. All responsibility for transportation of the items from the supplier's premises to the power plant shall be of the supplier.
