> Experience of having successfully completed similar nature or allied works during last 7 (Seven) years should be either of the following:

Copy of Income Tax PAN and Professional Tax Certificate clearance of current validity are to be submitted along with the application.

Application requesting for purchase of tender documents should invariably accompany the requisite fee for tender documents.

#### 10. Special Condition:

The intending bidders are requested to visit the worksite to assess the requirement of the work and formalities to prepare entry permits for labour/staffs etc. before submission of their tenders.

#### Other Terms and Conditions:

- 11. Bidders shall have to quote the rates in the rate sheet (Bill of Quantities and Schedule of Rates) enclosed with the tender papers.
- 12. Contractor shall submit service Tax Registration Certificate or service tax threshold limit certificate Service tax payable at actual for contractors part will be reimbursed by NEEPCO on submission of documentary evidence.
- 13. Rates quoted by the bidders shall be inclusive of all taxes and duties etc. but excluding Service Tax as applicable. Rates have to be quoted both in figures and words. In case of any mismatch between figures and words, the rates quoted in words will be considered for calculation of total amount.
- 14. In case of delay in execution of the work, ½ % (Half percent) of the value of the total work shall be recovered from the bill per week of delay of incomplete work subject to maximum of 10% (Ten percent) of the value of the work.
- 15. Contractor shall submit the EPF Registration Number, if already registered in EPFO, otherwise EPF deduction in respect of both employees and employer's contribution will be made from their bill(s) as per existing relevant norms. However, this will not relieve the Contractor from his responsibility.
- **16.** Laws, Regulations and Acts pertaining to engagement of Labours, environment protection, Safety & insurance etc. shall be applicable.
- 17. Security Deposit & Payment terms: 90% payment shall be released after successful completion of work certified by the Engineer-in-charge. Balance 10% (Ten percent) as Security deposit will be deducted from the each bill(s) for due performance of the work and the same shall be released on expiry of Defect Liability period of 6(six) months from the date of completion. In case, any defect is noticed during the Defect Liability Period, the contractor will have to rectify/correct the same at his cost and risk; else NEEPCO will get the work done at the cost and risk of the Contractor. All applicable taxes will be deducted from Bills as per statutory guidelines. However service tax will be loaded extra on quoted values before making deduction for the same.

- **18.** The Contractor shall have to supply all materials and labours etc. required for the work for successful completion of the same in all respect.
- 19. In case, the work is not been carried out the work as per specifications or not to the satisfaction of NEEPCO or the Contractor causes any damage to the work or property of NEEPCO or other damages not mentioned herein, NEEPCO shall have the right to recover any amount as considered suitable from the bill/ Security deposit/ any other amount due to the Contractor in NEEPCO.
- 20. Tenders received at the drop Box of the Office of the undersigned or by post within the specified time mentioned above shall be considered for acceptance. NEEPCO shall not be responsible for any delay in reaching the tenders by post or courier service. Tenders sent by Fax or e-mail shall not be considered for opening.
- 21. The Corporation is also not bound to accept the lowest tender. Issuance of Tender Papers shall not automatically qualify the bidder for the work. NEEPCO reserves the right to issue tender papers and reject any or all the tenders without assigning any reason thereof. The scope / quantity of the work may increase or decrease and for that no price escalation will be allowed.
- 22. Each bidder shall submit only 1 (one) bid, either individually or as a partner in a Joint Venture. A bidder who submits or participates in more that 1 (one) bid will be disqualified.
- 23. Withdrawal of bid at any stage is not allowed. If due to unavoidable circumstances bidder wishes to withdraw his bid by written request, the same shall be allowed only by forfeiting the Tender Document Fee & EMD. The bidder shall be disqualified for re-submission of bid for the instant tender.
