- Payment:** 100% of the quoted value/actual quantity of tyres available in the form of **Demand Draft drawn in favour of NEEPCO Ltd.** payable at SBI, KHEPA, Garampani Branch, P.O. Umrongso (SBI Code-4812) shall be deposited by the successful bidder to the O/o the Sr. Manager (E), Central Store, KHEP, NEEPCO Ltd. Umrongso within 7 days from the date of issue of the formal order. No payment shall be received by the Corporation on installment basis.

7. The bids will be opened at the time and date mentioned below in presence of bidder or his authorized representative (if any). No electronic recording device will be permitted during opening of the bids.

ii) **Date and time of opening of bids : 15-30 hrs of 14-02-2015.**

In the case of any bandh / holidays on the above mention date, the bid will be received and opened in the next working day at the same time as indicated above. No telex / fax / Telegraphic tender will be received.

8. **Earnest Money Deposit:** EMD @2% of the quoted value in the form of **Demand Draft** duly pledged in favour of **NEEPCO Ltd.**, payable at SBI, KHEPA, Garampani Branch, P.O. Umrongso (SBI Code-4812) should be submitted along with the tender. Tender without EMD shall be rejected.

- a. EMD submitted by the successful bidder (highest bidder) shall be retained as security deposit towards satisfactory execution of the order and will be released after lifting of entire quantity.

- b. EMD of the unsuccessful bidders will be returned only after finalization of the bid.

9. All rates and amount of the bid shall be legibly written in both figure and words. In case of any discrepancy between figure and words, the amount indicated in the words will be considered.

10. **Delivery schedule:** The tyres shall be lifted by the successful bidder at his own cost within 15 days from the date of payment and necessary clearance by the Sr. Manager (E), Central Store, KHEP, Umrongso or his authorized representative. The delivery clearance shall be issued on proof of payment.

10. Bids received later than the prescribed due date shall not be considered.
