3. **Earnest Money Deposit :** Earnest Money @ 2.5% (two & half percent) of quoted value in the form of DD duly pledged in favour of Ranganadi H. E. Plant, NEEPCO Ltd., Yazali should be submitted along with the tender. Our banker is S.B.I, Yazali (RHEP) Branch code – 9917. Earnest Money Deposit / submitted by the successful bidder shall be retained as Security Deposit towards satisfactory execution of the order and will be released after delivery of entire quantity to the satisfaction of the Corporation. EMD of unsuccessful bidders shall be released after finalisation of the Tender. All bidders should submit their bank account detail to release the EMD & deposit directly in their bank account.
4. **EXEMPTION TO SMALL SCALE INDUSTRIES.**  
Statutory exemptions for participating bidders registered under Small Scale Industries as per the Government of India Guidelines/Norms shall be considered.
