

The rates shall remain firm till the supply of materials. Quoted materials preferable with ISI marked. Transportation cost may also be quoted separately considering FOR RHEP, 43 Km. Lower Subansiri Dist., Arunachal Pradesh.

Preference will be given to Registered SMSE units on production of valid documents issued time to time Or any kind of exemption /concession from State / Central Govt. the bidder shall furnish documentary evidence to consider the same. Earnest Money Deposit / submitted by the successful bidder shall be retained as Security Deposit towards satisfactory execution of the order and will be released after delivery of entire quantity to the satisfaction of the Corporation. EMD of unsuccessful bidders shall be released after finalisation of the Tender. All bidders should submit their bank account detail to release the EMD & deposit directly in their bank account
4. **DELIVERY:** Delivery should be completed within **120 (One hundred twenty)** days from the placement of the technically & commercially cleared order.
