- 1. Scope:** The scope includes supply of Electrical Materials as per the specification indicated in the ANNEXURE-I (Schedule & Rate sheet) of the NIT. The Materials quoted must conform to relevant Bureau of Indian Standards (BIS) specification.
- 2. Bid validity :** 180 days from the date of opening of bids.
- 3. Date of Submission of NIT :** The tender must be submitted on or before 11:00 Hrs. of **10.03.2015**. The interested bidders are requested to drop their duly filled tender document along with all other relevant papers mentioned under terms & conditions of the NIT including cost of tender documents & earnest money as per prescribed format as indicated in the Tender Box kept at our **Transit Camp at Silchar**, address of which is indicated below. Vendors may also submit the tender document in sealed covers through courier/registered post to reach to the following address on or before **10.03.2015 up to 11:00 hours**. The Corporation shall not be responsible in any way for delay in receipt of tenders through courier/posts etc. Tenders received after the stipulated date and time shall be summarily rejected.
- 4. Date of Opening of NIT :** The tender will be opened on **10.03.2015 at 15:00** Hrs at NEEPCO Transit Camp, Sonai Road, Silchar in presence of the bidders or their authorized representative, if any. In case any of the date/dates mentioned above is declared a holiday or bandh, the next working day shall automatically be considered as the valid date for opening of tender.
- 5. Earnest money:** The complete tender document should be accompanied by an Earnest Money @ 2.5% for General and @1.5% for SC & ST on the quoted amount. The Earnest Money shall be deposited along with the tender in the form of Call Deposit/Demand Draft/Banker Cheque from any nationalized bank in favour of "NORTH EASTERN ELECTRIC POWER CORPORATION LIMITED," with validity for six months. Tenders not accompanied with EMD or Tenders accompanied with EMD of inadequate value may not be entertained and in such cases, tender(s) will be rejected.
- 6. Cost of Tender Paper:** Rupees 500.00 (Rupees Five Hundred) only in the form of A/C Payee Demand Draft/Banker's Cheque (non-refundable) duly pledged in favour of North Eastern Electric Power Corporation Ltd.
- 7. Rate :** Rates quoted by the bidders should be inclusive of all taxes & duties, freight, insurance, loading & unloading charges etc and should remain firm till completion of the entire supply in all respect in terms of NIT.
- 8. Payment:** 90% payment of the total admissible amount shall be made promptly within 30(thirty) days after receipt of specified materials in full & good conditions at Trial H.E. Project Site. The bidder has to submit bill/invoice in triplicate along with necessary documents for release of admissible payment. Balance 10% will be kept in lieu of security deposit and released after 6 (six) calendar months from the date of completion of entire supply. No part payment will be allowed. All payment shall be made on electronic transfer basis through State Bank of India, Vairengte Branch, Mizoram, INDIA. Hence bank details of the supplier, such as - Name of bidders, Name of the Bank, A/c. No., Branch Code, IFSC Code. photo copy of PAN Card, etc for the purpose of smooth transfer of payment is required.

9. Guarantee/Warranty : The items must be under warranted for a period of minimum 6 (six) calendar months from the date of delivery. The vendor must specifically and clearly mention the warrantee period for the items. During the warrantee period, if any defect/malfunctioning of the materials are found, the supplier shall rectify the same or replace the defective items free of cost at the purchaser's site at the earliest possible time, latest by within a period of 7(seven) days of notification.

10. Delivery period : The entire supply have to be completed within 45 (forty five) days from the date of issue of formal order. The Earnest Money will be forfeited in case the bidder refuses to supply the ordered materials or if the supplied materials are not as per the specifications mentioned in order.

11. FOR : Tuirial Hydro Electric Project, Dist.- Kolasib, Mizoram, (including all taxes, duties, etc. and freight insurance, Loading, Unloading Charges).
