SHORT NOTICE INVITING TENDER

Sealed tenders in prescribed tender forms under single bid system with 180 (one hundred and eighty) days validity are invited from experienced contractors for the following work:

1.	Name of Work:	" Repairing of the existing road from main Project Gate to the Power House of AGTP, NEEPCO Ltd., R. C. Nagar, Agartala, Tripura West, Pin – 799008 ".
2.	Estimated value:	Rs. 20,43,968/- (Rupees Twenty lakhs forty three thousand nine hundred sixty eight) only. The estimate value is excluding Service Tax which will be reimbursed on submission of documentary evidence.
3.	Earnest Money:	Rs.40,900/- (Forty thousand nine hundred) only in form of Demand Draft/Bankers Cheque in favour of "NEEPCO LTD ".
4.	Time of completion:	15 (Fifteen) days from the date of issue of Work Order.
5.	Tender Document Fee / Bid Fee:	Rs. 1000/- (Rupees One thousand) only in the form of Demand Draft / Banker cheque issued in favour of "NEEPCO Ltd.
6.	Sale of Tender Document:	Online at www.neepco.abcpurchase.com / www.neepco.gov.in/e-tender with effect from 7th July 2015 10:00 Hours (IST). Documents can be downloaded after vendor registration by paying Bidder Registration Fee of INR 3000/= (Rupees Three thousand) only which shall remain valid for one (01) year with an intimation to the undersigned. 7.	Time and Date of submission	Upto 13:00 Hrs (IST) of 28 th July 2015. The bidder has to upload authenticated documents in support of qualifying criteria in the online bidding system. The EMD & Bid Fee has to be submitted physically by post or in person to the office of the undersigned on or before opening date. Tender submitted without the EMD will be rejected outrightly.
8.	Time and date of opening of Tender	At 15:00 Hrs. (IST) of 28 th July 2015 at the office of the undersigned.

9. **Qualification & Experience:**

A) Experience of having successfully completed similar nature or allied works during last 7 (Seven) years should be either of the following:

- i) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

OR

- ii) Two similar completed works costing not less than the amount equal to 50% of the estimated cost.

OR

- iii) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Note: Similar works for (i), (ii) & (iii) above means **Road work**.

B) **Equipment capabilities:**

The bidder has to submit necessary documentary evidence for having minimum equipment capability in respect of the following:

- i) 80 – 100 KN Static / Vibratory Roller.
- ii) Paver finisher – Mechanical / Electronic.
- iii) Tipper.

Copy of Income Tax PAN and Professional Tax Certificate clearance of current validity & Labour license are to be submitted along with the application.

10. **Special Condition:**

The intending bidders are requested to visit the worksite to assess the requirement of the work and formalities to prepare entry permits for labour/staffs etc. before submission of their tenders. **The spreading / laying of hot bitumen premix carpet has to be carried out with Paver finisher.**

Other Terms and Conditions:

- 11. Bidders shall have to quote the rates in the rate sheet (Bill of Quantities and Schedule of Rates) enclosed with the tender papers.
- 12. Contractor shall submit **service Tax Registration No.** Service tax payable at actual will be reimbursed by NEEPCO on submission of documentary evidence as per prevailing norms.
- 13. **Rates quoted by the bidders shall be inclusive of all taxes and duties etc. but excluding Service Tax as applicable.** Rates have to be quoted both in figures and words. In case of any mismatch between figures and words, the rates quoted in words will be considered for calculation of total amount.
- 14. In case of delay in execution of the work, $\frac{1}{2}$ % (Half percent) of the value of the **total work** shall be recovered from the bill per week of delay subject to maximum of 10% (Ten percent) of the value of the work.
- 15. Contractor shall submit the **EPF Registration Number**, if already had, otherwise **EPF deduction** in respect of both employees and employer's contribution will be made from their bill(s) as per existing relevant norms. However, this will not relieve the Contractor from his responsibility.

16. Laws, Regulations and Acts pertaining to engagement of Labours, environment protection, Safety etc. shall be applicable.
17. **Security Deposit & Payment terms:** 90% payment shall be released after successful completion of work certified by the Engineer-in-charge. No running bill will be admissible. All applicable taxes other than service tax will be deducted from Bills as per statutory guidelines. Balance 10% shall be released after successful completion of defect liability period of 12 (twelve) months from date of completion of the work as certified the Engineer-in-charge.
18. The Contractor shall have to supply all materials and labours etc. required for the work for successful completion of the same in all respect.
19. In case, the work is not been carried out as per specifications or not to the satisfaction of NEEPCO or the Contractor causes any damage to the work or property of NEEPCO or other damages not mentioned herein, NEEPCO shall have the right to recover any amount as considered suitable from the bill/ Security deposit/ any other amount due to the Contractor in NEEPCO.
20. Tenders received online through above mentioned website within the specified time shall be considered for acceptance. NEEPCO shall not be responsible for any internet related issues.
21. The Corporation is also not bound to accept the lowest tender. Issuance of Tender Papers shall not automatically qualify the bidder for the work. NEEPCO reserves the right to issue tender papers and reject any or all the tenders without assigning any reason thereof. The scope / quantity of the work may increase or decrease and for that no price escalation will be allowed. Any increase in quantity shall be regularized as per BoQ rate.
22. Each bidder shall submit only 1 (one) bid, either individually or as a partner in a Joint Venture. A bidder who submits or participates in more that 1 (one) bid will be disqualified.
24. Bidders are requested to come with a valid photo I.D Card issued by Govt. of India/State Govt./Statutory Authority/Reputed Employer at least two hours before opening of tender due to mandatory security checks for entry/work in Power House area.
