3. Bids should be submitted in 2 sets consisting of one original and one copy, each being separately sealed and clearly marked "Original" or "Copy" and duly super scribing "PRE BID PRICE OFFER FOR EPC AND SUBSEQUENT O&M SERVICES for 10 YEARS FOR PV BASED SOLAR PLANT"
4. All the bids shall be prepared by typing or printing with indelible black ink in the proposal forms. Bids submitted by prospective bidders and the documents attached thereto shall be considered as forming part of the Contract documents.
5. Each sealed set of bids shall contain the following sealed covers:-
 - A) Sealed Cover-I: Techno-commercial Bid
 - The Techno-commercial Bid, in a single sealed envelope super scribing "Sealed Cover - I- Tender for EPC and Subsequent O&M services for 10 years for PV based solar plant", shall contain within it two parts, each sealed in separate envelope and super-scribed accordingly, containing the following:-

 - II. Technical and Commercial Bid super-scribing "Techno-Commercial Bid" containing

8. Only those bidders to whom the Bid Document has been issued as part of Limited Tender would be considered.

Bid submitted /sent by post must be through Registered Post with acknowledgement due/transmitted receipt/ Courier sufficiently in advance so as to reach the above address by the scheduled time and date indicated in below section. Any bid received after due date and time of submission, even on account of delay on the part of the Postal Authorities, will be rejected. The bidders are therefore requested to ensure in their own interest that their bids are delivered in time. NEEPCO will not be held responsible for delay or loss of documents.
10. The techno-commercial bids will be opened at the time and date set for opening for bids. Bidders authorized representative shall be permitted to attend the bid opening.
11. The Price Bids will be opened only for Bidders whose Techno-Commercial Bid has been found to be compliant to requirements. Considering the sensitive nature of the price bids, the bids will be kept confidential with NEEPCO till the finalization of solar opportunity for which bids have been received.
