Qualifying Requirement for Bidders:

Technical capability:

- The bidder shall be a manufacturer of the required LT Cables, or Authorised Dealer of Manufacturer of the required LT Cables.
- The bidder should have experience of completed supplies for Power Cables to State/ Central Power Utilities as under during the last 7 years ending last day of the month previous to the one in which this NIB is floated:
 - At least 3 (three) completed similar supplies, each of value not less than 40% estimated value; OR
 - At least 2 (two) completed similar supplies, each of value of not less than (ii) 50% estimated value; OR
 - At least 1 (one) completed similar supply of value not less than 80% (iii) estimated value.
 - 'Similar supplies' means supply and delivery of LT cables.
- Details, including year-wise value of supply executed, clients and documentary c. evidence of satisfactory performance alongwith order copies of LT cables shall be furnished.
- The bidder shall submit documentary evidence in support of the above. In case d. of authorized dealer of manufacturer, valid dealership certificate should be submitted.

(b) Net Worth:

The Net Worth of the bidder as on last day of the preceding financial year shall not be less than 50% of the Paid up Share Capital.

The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit & Loss Account Less (a) Expenses not written off (b) loss in Profit & Loss Account if not reduced from Reserves.

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 5(five) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

(c) Liquid Assets:

The bidder should have liquid assets or / and evidence to availability of unutilized credit facilities of not less than Rs. 2,50,58,013.00

The certificate of the Banker regarding the availability of unutilized credit facility should not be dated earlier than 30 (thirty) days prior to the date of opening the bid.

(d) Bid Capacity:

The available Bid Capacity of the Bidder at the time of submission of Bid, calculated as under should not be less than the estimated cost of the work put to tender:

Bid Capacity = $A \times N \times 2 - B$, where,

A = maximum value of works executed in any one year during last 7 (seven) years (at current price level).

N = Completion time of the proposed work in years.

B = Value at current price level of existing commitments and ongoing works to be completed during next N years.

Bid capacity shall be assessed at the time of submission of Technocommercial Bid, for which the bidder shall have to submit documentary evidence in support of "A" & "B" above along with their Bid.
