2. Submission and opening of Bids

The Purchaser (NEEPCO) reserves the right to go for Reverse Auction process or may finalize the tender without Reverse Auction, if required. However, the decision to conduct Reverse Auction or not will be conveyed to the short-listed bidders after opening of the bid.
