 - b) Two completed works costing not less than the amount equal to 50% of the tendered value OR
 - c) Three completed works costing not less than the amount equal to 40% of the tendered value.

 - (iii) Trade License
 - (iv) Vat Registration No
 - (v) Certificate to be enclosed as a proof of SC/ST.
