SHORT NOTICE INVITING TENDER

Undersigned on the behalf of North Eastern Electric Power Corporation Ltd (NEEPCO), a Public Sector Enterprises under the Ministry of Power, Govt. of India invites sealed two part bids from the Manufacturer's /Authorised Dealers in single stage two envelope bidding system with minimum 180 (One hundred & eighty) days validity for manufacturing, Supply, installation, testing & commissioning of Pillar Drilling & Pedestal Grinding Machine for 3X135 MW Dikrong Power House , Ranganadi HE Plant , NEEPCO Ltd. , Yazali, Arunachal Pradesh as per Technical specification enclosed at Annexure-A, Price schedule & quantity at Annexure-B and terms & conditions indicated below.

1. SCOPE OF WORK

- 1.1 The scope of work covers the manufacturing, Supply, installation, testing & commissioning of Box Column Drilling machine & Pedestal Grinding Machine along with all the required accessories as per the technical specification enclosed in Annexure-A. The scope shall include freight & Insurance and delivery at site.

2. TERMS AND CONDITIONS:

- 2.1 The Bids should be submitted in two sealed envelope (Part-I & Part-II).

One envelope containing Techno-Commercial bid (Part-I) should be super scribed with "Techno-Commercial Bid" and second envelope (Part-II) containing price bid should be super scribed with " Price Bid". Both envelop should be put in one envelop super scribed with following.

- (i) manufacturing, Supply, installation, testing & commissioning of Box Column Drilling machine & Pedestal Grinding Machine for Dikrong Power House, Ranganadi H.E. Plant, NEEPCO Ltd, Yazali, Arunachal Pradesh.
- (ii) Bid No. : RHEP/PH&SY(M)/ 04 /15-16 dtd. 24/09/2015
- (iii) Date of opening : 03 /11 / 2015

2.2 TECHNO-COMMERCIAL BID (PART-I):

- 2.2.1** Bidder should submit self attested copy of their Tax payer Identification Number, Tax/VAT Registration, Service Tax Registration and PAN Card as applicable.
- 2.2.2** Bidders shall also submit copy of valid sales Tax /VAT clearance certificate of last 02(two) years duly issued by competent authority.
- 2.2.3** The bidders should be an original equipment manufacturer (OEM) or system Integrator of OEM/ authorized dealer, who must have supplied at least 02 (two) nos Pillar Drilling & Pedestal Grinding Machine each to any public undertaking/Govt. (either central or state govt.) organisation in India during last 5(five) years, which shall be currently in use to the satisfaction of the customer. The bidders should furnish copies of the detailed order and also performance certificate from the customer, which should indicate date of successful commissioning and also indicate that the same are currently in use to the satisfaction of the customer.
- 2.2.4** (a) the bidder should have enough financial credential whose turn-over is not less than 50 (Fifty) Lakh.
 (b) The bidder should not have reported losses for the past 3 years.
 (c) The experience has to be in the name of bidder only and that of individual / partners /Directors shall not be considered. In case of subsidiary company qualifications of the holding / Group Company shall be considered for meeting the pre-qualification criteria, only if it is a 100% subsidiary of a parent company having requisite pre-qualification criteria and the parent company gives a corporate guarantee for completion of contract along with O&M as per the bid conditions.

Bidders shall be pre-qualified on the basis of documents furnished along with Techno commercial bid in support of above mentioned criteria. The decision of the NEEPCO will be final and binding in this regard. Bidders have to declare whether they are registered under Micro, Small & Medium Enterprises Development (MSMED) Act or not, if yes then bidders have to provide registration number along with copy of the registration certificate.
 Bidders as a consortium shall not be allowed to participate in this bid.
 Bidders which have earlier been suspended or banned or whose contracts have been terminated by NEEPCO or any other government organisation/undertaking shall not be eligible to participate in this bid during the currency of the suspension or banned period.
- 2.2.5** In case of authorised system Integrator/ authorized dealer of OEM, the bidder should submit the authorised certificate from the OEM.
- 2.2.6** The bidders shall not have been blacklisted by any Govt./Govt. agency in India. Self declaration to that effect should be submitted along with the technical bid.
- 2.2.7** All technical and commercial aspects pertaining to Part I (Technical and Commercial bid except price) of the tender will be finalised prior to opening of Part II (Price bid) and no change in this regard shall be accepted after opening of Part II (Price bid).
- 2.2.8** **Price Basis:** The Price shall be quoted on FOR project site basis i.e. Dikrong Power House, Ranganadi HE Plant, Hoj, Papumpare Dist., Arunachal Pradesh. The rates for Taxes & Duties, service tax, any other applicable taxes, if any, should be separately and clearly indicated in the bid.

2.2.9 BID SECURITY/Earnest Money Deposit : The bidder shall furnish along with his bid, a Bid Security/Earnest Money Deposit amounting ` 28,000.00(Rupees Twenty Eight Thousand) only. The Bid security / EMD shall be in the form of Demand Draft/ Bank Guarantee duly pledged in favour of Ranganadi H E Plant, NEEPCO Ltd , Yazali (SBI Yazali branch (RHEPA) code: 9917) Bid without requisite Bid Security/EMD shall be summarily rejected. Format of Bank Guarantee in lieu of EMD is enclosed.

(i) EMD submitted by successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released only after delivery of the entire quantity of the material to the satisfaction of the Corporation. If successful bidder fails to execute the order then EMD shall be forfeited by corporation.

(ii) EMD of all unsuccessful bidders will be returned only after finalization of the bid.

(iii) Following units are however, exempted from payment of EMD:

- a) Public Sector Enterprises
- b) Units registered with National Small Industries Corporation (NSIC) subject to :
 - The unit being registered with NSIC for the item tendered.
 - Registration certificate being valid as on date of quotation.

As the case may be, the bidders must submit proof to show that they are PSE or a valid NSIC Registration Certificate.

2.2.10 Terms of Payment:

- (i) 80% (Eighty percent) payment shall be made after receipt of material at site in full & good condition.
- (ii) 10% (Ten Percent) payment shall be released after the the successful testing & commissioning of the equipments at site.
- (iii) Balance 10% (ten percent) payment shall be released on submission of Proforma Bank guarantee of equivalent amount, which shall cover one month more than warranty period.

2.2.11 Supply part : The delivery of the materials shall be completed within 03 (three) months from the date of issue of order.

2.2.12 Taxes & Duties: Taxes, duties, service tax & any other applicable taxes, if any, should be clearly indicated in the bid.

2.2.13 Submission of Bid: The Bid in sealed envelope may be submitted to the office of the undersigned in person or by any authorized representative of the bidder or by means of registered post and must be submitted only under the bidder's letter head with details like complete address for communication, telephone/ fax no.,name of contact person etc. so as to reach at this end on or before the due date. Bid received through fax / mail / telegram etc. shall not be acceptable. The corporation shall be not be held responsible for any postal delay.

2.2.14 The bidders should sign and stamp each and every page of the tender document & supporting documents submitted with the bid in support of acceptance of terms & conditions. The supporting documents should be serially numbered and total number of pages submitted, should be indicated in the covering letter.

2.2.15 The date for receiving & opening of bid : The bids shall be opened at the time and date mentioned below in presence of authorized representative (if any) of the bidders.

- (ii) **Date and Time of opening of Bid (Part-I): 03.11.2015 at 15.00 Hrs**

- (iii) The Part-II Bid (Price Bid) of only such bidders whose Part-I bids are found acceptable will be opened. Due date and time for opening of the Part-II (Price Bid) will be decided by the Purchaser and the same shall be intimated in advance only to such qualified bidders, whose bids are found acceptable in Part-I to enable them to participate in the tender opening. No change in Technical / Commercial conditions shall be accepted after opening Bid.

The Price Bid of unsuccessful bidders shall be returned by post on the address mentioned by bidder. No any correspondence for such bid shall be entertained in future.

- 2.2.16 Technical Specifications:** Details of technical specifications of Box Column Pillar Drill machine & Pedestal Grinding Machine is enclosed at **Annexure-A**. Bidders should carefully read/study the technical specifications before quoting the prices.

- 2.2.17** All technical and commercial aspects pertaining to Part I (Techno- Commercial bid except price bid) of the tender will be finalised prior to opening of Part II (Price bid) and no change in this regard shall be accepted after opening of Part II (Price bid).

2.2.18 EVALUATION OF PART-I: TECHNO-COMMERCIAL EXCEPT PRICE BID

The Bids of such bidders who meet the qualifying requirements stipulated in the bid document (such as experience and financial criteria) shall only be considered for detailed techno-commercial evaluation. Detailed technical evaluation will also take into account the financial and technical capabilities as well as such other criteria deemed necessary and appropriate.

2.2.19 CATALOGUES/TECHNICAL LITERATURE

All necessary catalogues/drawing/technical literature data as are considered essential for full and correct evaluation of the bids shall invariably accompany the PART I (Techno-Commercial bid except price) of the tender.

- 2.2.20** All the enclosed Tender documents along with the covering letter will form part of the tender. Bidders are requested to carefully study all the documents/annexure and understand the conditions, specifications, etc., before quoting their rates. Offers should strictly be in accordance with the tender terms & conditions and our specifications.

- 2.2.21 Liquidated damage:** In case of delay in supplying on part of supplier after schedule delivery period, LD @ 0.5% per week of delay subject to a maximum of 5% of the contract value shall be applicable subject to force majeure.

2.2.22 Guarantee / Warranty :

- (i) The material supplied shall be warranted / guaranteed against any manufacturing defect/ poor workmanship, technical defect for a period of 18 months from the date of receipt of materials at site or 12 months from the date of commissioning whichever is earlier.
- (ii) The successful bidder shall supply, commission & test the equipment to the satisfaction of the Consignee/ Engineer-in charge. If the equipment supplied are found defective, the same shall be replaced by the supplier without any additional cost to the Corporation immediately on intimation from this end.

- 2.2.23 Make/Brand :** Bidders shall mention the make/Brand of material in their bid. The bid without indicating the brand/make shall be rejected.
- 2.2.24** The language and currency applicable are English and Indian currency respectively & shall be legibly written. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between unit rate and total amount, the total amount evolved by multiplying unit rate and quantity shall be considered.
- 2.2.25** The quantity of the material to be supplied as mentioned in the schedule of prices is indicative and is liable to change during the time of placing the order.
- 2.2.26** Any action on the part of the bidder to revise the price or to change the structure of the price at his own instance after opening of the bid and within the validity of the offer shall not be acceptable.

3. PRICE BID- PART-II :

The bidders shall quote the prices as per enclosed **Annexure-B** (Price schedule & Quantity) and submit in separate envelope (Part-II).

The Part-II Bid (Price Bid) of only qualified bidders shall be opened. Due date and time for opening of the Part-II (Price Bid) shall be decided by the Purchaser and the same shall be intimated in advance only to qualified bidders. No change in Technical / Commercial conditions shall be accepted after opening Bid.

The Price Bid of unsuccessful bidders shall be returned by post on the address mentioned by bidder. No any correspondence for such bid shall be entertained in future.

The Corporation does not bind itself to accept the lowest tender and reserves the right to reject any or all tenders without assigning any reason thereof in the interest of the Corporation.

Whereas the North Eastern Electric Power Corporation Ltd., (herein after referred to as the Corporation) has called for tender forin connection with the Project, vide NIT No. Dated.....and whereas (hereinafter referred to as the Contractor) has submitted bid/ bids for the aforesaid works/ supply.

And whereas one of the conditions of the bid is that the intending bidders should furnish, in lieu of Earnest Money, a Bank Guarantee for ` (Rupees.....) only along with the tender.

Now, therefore this witnesseth:-

We, the (Name & address of the Bank) a Nationalized Bank of India having its registered office at (hereinafter referred to as the Bank) in consideration of the Corporation entertaining the bid submitted by the bidder do hereby agree with the Corporation.

That it shall in the event of the contractor failing to keep open the bid for acceptance for a period of six/ eight calendar months from the date of opening of bid and for failing to execute an agreement in the form prescribed incorporating the terms and conditions of contract as per the tender submitted by him and accepted by the Corporation with or without modifications within 30 days from the date of acceptance of the tender or to renew this Guarantee for a further period as demanded by the Corporation, pay to the Corporation without any demur, reservation, contest, recourse or protest and or without any reference to the contractor and without waiting for the results of any litigation, dispute whatsoever in this connection pending before any Court, Tribunal, Arbitrator or any other authority and on a mere demand by the Corporation the sum of ` (Rupees.....) only.

That as to whether the occasion has arisen for the demand of the amount covered by the Bank Guarantee, the decision of the Corporation shall be final and shall be accepted by the Bank without any reference to the contractor.

That the Guarantee herein contained shall remain in full force and effect during the period taken for finalizing the contract and execution of the agreement. That it shall continue to be enforceable until the Guarantee is fully discharged.

That this Bank Guarantee shall be enforceable against the Bank even if any negotiable instrument shall be outstanding against the Bank at the time of the proceeding.

That is to give effect to the Guarantee; the Corporation shall be at liberty to act as though the Bank were the principal debtor:

That the Bank shall not be released of its obligation under this Guarantee by any exercise by the Corporation of its liberty with reference to the matters aforesaid or any of them or by reason or any other acts of omission on the part of the Corporation or any other indulgence shown by the Corporation or by any other matter or thing whatsoever which under law would but for this provision, have the effect of relieving the Bank.

That the Guarantee shall remain in full force and effect notwithstanding any neglect or forbearance or delay in the endorsement of the same.

And that the Bank shall not revoke the Guarantee during its currency except with the previous consent in writing of the Corporation.

Notwithstanding, anything contained hereto before it is mutually agreed:

That the liability under this Bank Guarantee, shall not exceed
(Rupees.....) only.

That it shall be in full force only for a period of months from the date it bears and it will hold good for any demand made by the Corporation in the meanwhile.

And that if any further extension of this Guarantee is required the same shall be extended to such required period on receiving instructions from the Corporation and failure to comply such required extension by the contractor shall be treated as claim of the above mentioned sum by the Corporation upon the Bank.

The liability or obligation of the Bank under this guarantee bond shall not be affected or suspended by any dispute between the purchaser and the supplier and the payment under this guarantee bond need not wait till the disputes are decided by a Competent Court or Tribunal or any other authority and that any payment made by the Bank to the purchaser under the guarantee bond shall be deemed to have been rightfully and lawfully made.

Lastly the Bank also assure that the guarantee bond will not be discharged due to the change in the constitution of the Bank or the contractor.
