
Terms & Conditions:

- Scope:** Supply, transportation, transit insurance, delivery, loading & unloading of the above mentioned items as detailed above. Supplier should submit valid dealership certificate along with their offer.
- Delivery & delivery point:** All the materials shall be delivered within 45 days to the address of the consignee from receipt of formal order.
- Liquidity Damage:** Shall be applicable @ $\frac{1}{2}\%$ (Half percent) of the total value of the undelivered items per week subject to a ceiling of 10% of the ordered value.

04. **Rate:** Bidder shall quote unit as well as total item wise prices for the materials. Rates should be quoted both in figure and words. In case of any discrepancy between figures and words, the amount indicated in words will be considered. In case of any discrepancy between "unit rate" and "total amount" the total amount evolved by multiplying the unit rate and quantity shall be considered.
The bidders shall fully make himself aware of the applicable taxes & duties for supply of goods at Tripura & submit total FOR destination prices showing break-up of basic price, applicable taxes & duties, freight & insurance charges. If no break-up is given, it will be considered that the quoted price is FOR destination price inclusive of all taxes & duties. In that case all the applicable taxes & duties levied during the supply of the material shall be borne by the supplier.
All prices shall remain firm till completion of the supply. For concessional CST, "C" Form shall be issued.
05. **Earnest money:** Rs. 1200/- (One Thousand Two Hundred) shall be deposited as earnest money in the form of Call Deposit from any Nationalized Bank pledged in favour of Agartala Gas Turbine Power Plant, North Eastern Electric Power Corporation Ltd., failing which their quotation shall not be considered. If a bidder withdraws the tender while it is under consideration or after placement of order, his bid security/EMD shall be forfeited along with other action, as the Corporation deems fit. The EMD shall be made payable without any condition to Purchaser. The EMD of all unsuccessful bidders shall be returned only after finalization of the bid.
06. **Payment:** 100 % (Hundred percent) payment for supply along with taxes & duties, freight and insurance shall be paid on receipt of materials in full and good conditions at site.
07. **Guarantee / Warranty:**
- The products supplied must be guaranteed/warranted as per manufacturer's norms or for a period of 12 months from the date of despatch against manufacturing defect/defective workmanship.
 - The successful bidder shall supply the materials to the satisfaction of the site Engineer-in-charge /consignee. Defective materials shall be replaced by the supplier at free of cost immediately on intimation from this end.
08. **Submission of Bid:** The bidder shall submit their Quotation and EMD in a Sealed Envelope to the O/O the Sr. Manager (E) O&M, AGTP, NEEPCO by means of Registered Post or in person only under the bidders letter head with details like complete address, Telephone/Fax Nos. email ID, dealing person etc. So as to reach at this end on or before the due date. Offer received through Fax/Mail/Telegram etc. should not be acceptable.
09. The Time and date for submission & opening of bid against this Tender shall be as under;

- In case 30-01-2013 is a holiday, the Quotation shall be opened on the next working day at 16:00 hrs.
